Regular meeting of the City Council: Austi ,Texas, July 5th 1917:

The Council was called to order by the Mayor; Roll Called:

The Mayor laid before the Council the following reports of City Officers for the Month of June 2917, which were read and filed, vis:

Mayor Wooldridge offered the following resolution :

Whereas, in view of the fact that the families of the three Metsenthin Brothers ,Fred K Metninthin, Paul Metxenthin, and W W Metsenthin, have, in the judgement of the City Council, been sufficently punished in the enforcement of the large fine and penalties assessed against him ,the said W W Metzen thin, in cause NO 12060, State of Texas vs W W Metsenthin,

Be it resolved by the City Council of the City of Austin, Tex a:

That the fine and penalties in causes numbers 11733, and 11736 imposed against Fred K Metzen thin and Paul Metsenthin respectively, be and the same are hereby remitted.

Austin, Texas, June 28th 1917:

To the Hon Mayor and City Council ,

Austin, Texas.

Gentlemen :

Previous to the time that your honorable body accepted "EnfieldA" addition streets, sidewalks, etc, we had at our expense constructed about two miles of Cement sidewalks 4' wide. We made these sidewalks this width in order to preserve the trees and the natural beauty of the land ,Therefore, we now petition your honorable body to deviate from your regulation woth and to give instructions to have all further sidewalks in " Enfield A " constructed 4' wide in order to conform with those already constructed. We feel that this difference in width of the sidewalks will not be noticed at all as "Enfield" Addition is a " Park" addition within itaself.

July 7th 1917:

The Mayor laid before the Council the following resolution :

Be it resolved by the City Council of the City of Austin, Texas:

That a permit is hereby granted the Gulf Refining Company to install and maintain a hose rack, of a type to be approved by the Supt of Police and Public Safety, at the curb line in front of their place of business at Nos 601 & 607 West 6th street.

Resolved further:

That in connection with this hose rack the said Gulf refining Company is likewise authorized to install and maintain two small pipe lines across and underneath the sidewalk in front of Nos 601-607 West 6th street in such a position as may be designated by the Supt of Streets and Public Improvements.

Resolved further:

That the said Gulf refining Company shall install and maintain at the top of and upon the hose rack hereby authorized, an electric light of not less than 40 watt power and placed in a globe of not less than ten inches in diameter, which electric light must be kept illuminated daily between thirty minutes after sun-set and midnight during the existence of this permit.

Resolved further:

That the hose through which air or water is conveyed from the store house must be kept, when out in actual use, neatly coiled and suspended from the brackets on the rack hereby authorized to be installed.

Resolved further:

That the work under this resolution authorized to be installed and maintained, must be installed and maintained, where not otherwise assigned, under the immediate supervision of the City Engineer of the City of Austin, Texas, who is hereby authorized to prescribe the necessary specifications for the work herein authorized to be done.

That in connection with and at the termini of these two pipes near the curb line ,the said Gulf Refining Company is likewise authorized to install and maintain in and under-neath the sidewalk space in front of 601-607 West 6th st street a box for the purpose of enclosing the termini of the two pipes hereby authorized to be installed ,said box to br constructed with a cast iron cover, set flush with the top of the sidewalk.

That the box hereby authorized to be installed shall be kept securely closed at all times except during the acruat filling of the gasoline storage tanks through the pipes herein authorized to be installed.

That the work under this resolution authorized to be installed and main- tained must be installed and maintained, where not otherwise assigned, under the immediate supervision of the City Engineer of the City of Austin, Texas, who is hereby authorized to prescribe necessary specifications for the work herein authorized to be done.
