Motion was seconded by Councilman Mueller, and same prevailed by the following vote: Ayes, Mayor McFadden, Councilmen Mueller, Pannell, Reed, and Steck, 5; nays, none.

Mayor McFadden laid before the Council application of J. A. Compton for the installation of a gasoline pump and tank at 2104 East Avenue; also letter of the Safety Committee stating their reasons for withholding their recommendation of same until certain adjustments could be made by Mr. Compton. Councilman Reed moved that permit be not granted until Mr. Compton had complied with the suggestions and requirements as outlined by the Safety Committee.
