vestigated the request of M. H. Grockett that he be advised if a filling station mould be permitted at the sourceast correr of the intersection of Soth and Guadalupe Streets. We do not find any unusual condition there and if a formal request was made by the party who was going to install the station, we would submit an approval for a permit, subject to the usual limitations and restrictions after receiving a jayout plan of the proposed installation. After review by the Sity Council, we believe that Mr. Grockett could be advised that the Safety Committee would submit such a recommendation subject to the limitations for same.

Gentlemen:

, We, your committee on the application of E. Joseph , asking permission to install and operate a drive-in gasoline filling station at SOI East 6th Street, make the following report:

We, the committee, recommend that this permission be granted, subject to the following conditions:

1. That all buildings and equipment shall be placed inside of the property line, correct lines to be obtained before construction starts or equipment is installed, Lines and grades to be obtained from the City Engineering Department for entrances and driveways, building plans to be approved by the City Building Inspector.

2. That ceiling of that portion of the building that extends over driveways shall be covered with metal. Supports for portion extended over driveway to be supported by brick or reinforced concrete pillars.

3. That gasoline storage tanks and pumps, and equipment used in connection

therewith shall be of an approved type, and shall bear the label of the Mational Board of Fire Underwriters. All equipment to be installed in compliance with City and State regulations governing such installations. All equipment to be inspected and approved before being placed in service.

4. That gasoline pumps and other equipment used in connection with the operation of a gasoline filling station shall be so located that cars receiving service therefrom will not in any manner obstruct the sidewalk, street or alleyway. The pumps shall be at least ten feet inside of the property line.

5. That electric lights only shall be used for lighting purposes, and all electric wiring shall be done in compliance with regulations governing the wiring of gasoline filling stations, and shall be approved by the City Electrical Department.

6. That "NO SMOKING" signs shall be displayed at all times, and no person shall be permitted to smoke or have any open flame on premises where gasoline is sold or stored.

7. That there shall be kept in an accessible place at all times a chemical fire extinguisher for emergency use.

5. That provision shall be made to take care of waste oils and water by having the proper connections with storm or sanitary sewer. Connections to be made under the supervision of the City Engineering Department.

9. That all gasoline pumps, tanks, equipment and piping connected thereto shall be inspected and approved by the City Plumbing Inspector.

10. That a ground plan of the filling station, hereto attached, and marked Exhibit "A" as prepared by the City Engineer, which has been reviewed by the architect representing Mr. Joseph, which plan shows proposed location of pumps, driveways, method of draining away waste water and oils, shall show the use of the portion of the City streets and shall be followed by the constructor of this filling station.

11. That all exterior curb work shown in red on the City Engineer's plan, together with all concrete curbs not already constructed, shall be built of concrete, together with a gutter one and one-half $(l\frac{1}{2})$ feet wide opposite all of said curb,

12. That the filling station shall be so constructed that all floor washings, waste from cars shall be concentrated into a drain inside of the building in such a manner that no such waste water or oil shall cross any sidewalk or ramp constructed on City property.

13. That the owner of the property shall construct all necessary storm sewers to conduct the water from said concentration point and from his wash rack collectors to a City storm sewer on the east side of East Avenue at the alley line between 5th and 6th Streets.

14. That permission shall be granted subject to the above conditions and the present and future rules and regulations and ordinances of the City of Austin, Texas, applying to or regulating gasoline filling stations, and said permission shall be held to be granted and accepted subject to all necessary, reasonable and proper, present and future regulations and ordinances of the City of Austin, Texas, in the enforcement of proper police, traffic and fire regulations; and the right of revocation is retained if, after hearing, it is found by the City Council that the said E. Joseph has failed and refused, and will continue to fail and refuse to perform any such conditions, regulations and ordinances.
