Councilman Haynes introduced the following resolution:

Whereas, the Board of Equalization, per statement attached, agreed to make the following reductions on valuation of property assessed to Mrs. A. L.W. Preston for taxes of 1921, to-wit:

Part of Outlot 24, Division "D", valuation on ground \$6400.00, reduced to \$5000.00; valuation on improvements, \$3000.00, reduced to \$2665.00, making a total reduction of \$1735.00, but failed to make change on the rolls, Therefore.
