The Mayor laid before the Council the following resolution: RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS:

The March reports of the Public Weigher, Sealer of Weights and Measures, and Assessor and Collector, also a special report of the City Engineer on the progress of construction at the sewage disposal plant with an estimate of cost, were read and ordered filed.

Councilman Bartholomew offered the following resolution: Whereas, in our opinion, Hon. A. P. Wooldridge, at this time Mayor of the City of Austin, Texas, and now terminating his fifth consecutive term of service as Mayor, has since he has been Mayor, and for a generation of time before he became Mayor, been an exceptionally useful citizen of Austin, and one whose services to Austin, especially before he became Mayor, were largely disinterested as well as useful and important; and

Whereas, it can be truthfully claimed for Mayor Wooldridge that he is a man of foresight as well as a man of action; and

Whereas, among the many large and useful things accomplished by Mayor A. P. Wooldridge for Austin was the location by popular vote of the University of Texas in this city in the fall of 1881, to which work it is represented to us, and we believe the representation to be a fact, that he gave the bulk of his time from March to September of that year, and in addition to his time and labor, gave liberally of his means, all of which facts we are informed and believe are of record in the archives of the University of Texas; and

Whereas, said A. P. Wooldridge on the 1st day of January, 1888, and subsequently on the 25th day of June, 1889, as is evidenced by the files of the newspapers of this city, originated the idea of a power dam across the Colorado River at Austin and out of his personal means liberally contributed to the expense of the necessary surveys and other preliminary work upon which to base a plan for the construction of said dam, and which dam, although now in a state of incompleteness, will yet, in our judgment, if properly completed prove to be of great benefit to Austin; and

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS: That in recognition of the value of the public services of A. P. Wooldridge to the City of Austin in the idea of the Dam, in recognition of the great value of his work in the location of the State University in this city, and in recognition of his other public services, the public roadway from the International & Great Northern Railway crossing at the western extension of West Sixth Street to the site of the Austin Dam in the City of Austin, Texas, be and the same is hereby named and shall hereafter be perpetually known and called Wooldridge Avenue. 181

When he had finished reading the foregoing resolution, Mr. Bartholomew spoke in terms of praise of Mayor Wooldridge, and in particular referred to the pleasant associations of the ten years during which he and Mr. Wooldridge and Mr. Powell had served together in the Council.

Councilmen Haynes and Anthony seconded the motion to adopt, and expressed their pleasure at being able to vote for such a resolution.

Mr. Powell before ordering the roll call addressed the Council, expressing his high estimate of the services rendered by Mr. Wooldridge to the City of Austin and his pleasure at having been associated with him during the past ten years.

The resolution was adopted by the following vote: Yeas, Councilmen Anthony, Bartholomew, Haynes, and Powell, 4; Mayor Wooldridge not voting.

APPROVED, Apr. 3, 1919: P. W. Powell, Mayor Pro Tem.

Mayor Wooldridge expressed feelingly his gratitude to his colleagues for this compliment paid him, and commented on the harmony and good-will that had prevailed in the Council, in spite of occasional differences of opinion, during the whole time of his service as Mayor.

N. Railroad to the Austin Dam.


The resolution was adopted by the following vote: Yeas, Coun-

On this motion Mayor Wooldridge voted nay and Councilmen Anthony, Bartholomew, Haynes, and Powell yea.

Councilman Bartholomew then moved that the matter of the resolution adopted on Mar. 28, 1919. ordering the putting in of sidewalk and curbing on the north side of Fifth Street between Rio Grande and Nueces Streets, as reconsidered by the action of the Council of this



day be referred to the incoming Council for its action thereupon. This motion prevailed by a vote of 5 yeas, no mays. The Council then adjourned.
