The Council then adjourned.

SPECIAL MEETING OF THE CITY COUNCIL: Austin, Texas, June 18, 1918.

The Council met with all members present.

After the Council had heard a statement by W. H. Stacy, representing the Citizens Loan and Investment Company of Austin, the Mayor offered the following resolution:

Whereas, on the 19th day of July, 1913, the Citizens Loan and Investment Company of the City of Austin, Texas, entered into a contract with the City of Austin, Texas, for the construction of a system of water mains to and through Travis Heights in said City of Austin, Texas, under the terms of which contract, amongst other things, the said Citizens Loan and Investment Company agreed to deposit with the City of Austin, Texas, a sum equal to one-sixth of the total cost of said water mains and was to do certain other things as stipulated in said contract, especially guaranteeing a certain income to the City of Austin from said water mains laid into Travis Heights; and

Whereas, the City of Austin in said contract agreed that when a total bona fide gross income of 15% of the cost of the construction of said water mains into Travis Heights was realized from the use of said water mains to said City of Austin then the guarantees of said Citizens Loan and Investment Company should cease; and

Whereas, said gross income on the total cost of said mains into Travis Heights is now substantially realized.

Now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS:

- 1. That the guarantees called for in said contract be and the same are now hereby waived and released.
- 2. That the one-sixth part of the total cost of said water mains and the laying of said water mains into Travis Heights, amounting to \$893.65, be and the same is hereby ordered to be refunded to the said Citizens Loan and Investment Company.
- 3. That the sum of \$893.65 be and the same is hereby appropriated out of the surplus funds of the Water and Light Department of the City of Austin, Texas, as a refund to the said Citizens Loan and Investment Company of the City of Austin, Texas, of the amount deposited by said Citizens Loan and Investment Company as a guarantee under its contract with the City of Austin, Texas, dated July 19th, 1913.

The resolution was adopted by the following vote: Yeas, Eayor Wooldridge, Councilmen Anthony, Bartholomew, Haynes, and Powell, 5; nays none.

APPROVED, June 18, 1918: A. P. Wooldridge, Layor.

Councilman Haynes offered the following resolution:

Whereas, the operation of the motor truck recently purchased for the use of the Sanitary Department has enabled the work of the department to be prosecuted with the use of fewer mules than have been heretofore used, and the cost of feed being very high,

Therefore.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That H. L. Haynes, the Superintendent of said department, be and is hereby authorized to sell two old mules of the department for the sum of Two Hundred and Fifty (\$250.00) Dollars, the sum offered by Mr. John Wear.

The resolution was adopted by a vote of 5 yeas, no nays.

In obedience to the City Charter, I have the honor to report the following as the vote by wards in the election held on June 18, 1918, for the authorization of an issue of \$100,000.00 of sewage disposal plant bonds:

Ward No. 1: For the bonds, 47; against, 11; one vote invalid.

Ward No. 2: For the bonds, 48; against, 10.

Ward No. 3: For the bonds, 167; against, 23; three votes thrown out as invalid.

Ward No. 4: For the bonds, 144; against, 28; one vote invalid.

Ward No. 5: For the bonds, 70; against, 20.

Ward No. 6: For the bonds, 39; against, 14.

Ward No. 7: For the bonds, 62; against, 18.

Total vote for the bonds, 577; total against, 124; invalid ballots, 5; total vote cast in said election, 706.
