#### REGULAR MEETING OF THE CITY COUNCIL:

Austin, Texas, January 20, 1921

The Council was called to order by the Mayor. Roll call showed the following members present: Mayor Yett, Councilmen Alford, Graham, Haynes and Ward, 5; absent, none.

The Minutes of the last meeting were read and upon motion of Councilman Haynes, were adopted by the following vote: Ayes, Mayor Yett, Councilmen Alford, Graham, Haynes and Ward, 5; naves, none.

The applications of Billy Ebner to erect electric signs at Seventh Street and Congress Avenue and the Lyric Colored Theatre on East Sixth Street were granted , upon the recommendation of the City Electrician, by the following vote: Ayes, Mayor Yett, Councilmen Alford, Graham, Haynes and Ward, 5; naves, none.

Councilman Alford introduced the following resolution:

WHEREAS, it appears from the attached affidavit of J. C. Moore that he was the owner of one sorrel roach mane horse and one bay mare which were impounded by the City of Austin on January 7th, 1921, and sold at the city pound on the 18th day of January, 1921, for the sum of Thirty-five Dollars and Twenty-five Cents (\$35.25); and

WHEREAS, according to the City Ordinance governing same, the said J. C. Moore is entitled to the sum of Twenty-four Dollars and Twenty-five Cents (\$24.25) out of the sale of said live stock;

Now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the sum of Twenty-four Dollars and Twenty-five Cents (\$24.25) arising from the sale of said live stock, be and the same is hereby refunded to the said J. C. Moore and the Clerk of the Corporation Court of the City of Austin is hereby authorized to make such refund.

Osborne, Bert C. Brady, Rufus C. Stoval, W. H. Maddox, Tom J. White, J. K. Rambo, M. C. Leonard, Geo. W. Patterson, S. J. Kelley, J. A. Woody, Joe Smith, and S. C. Loomis; and

BE IT FURTHER RESOLVED:

That none of the above persons shall be allowed to carry arms, nor shall receive any compensation for his services as special policeman, but shall take the oath of office as required by law.

The above resolution was adopted by the following vote: Ayes, Mayor Yett, Councilmen Alford, Graham, Haynes and Ward, 5 ; naves, none.

The report of Dr. A. A. Biebel, Meat and Dairy Inspector, for the month of December was read and ordered filed.

Councilman Haynes moved that the City Clerk be authorized to place all election returns of the special election held December 14th, 1920, in one box and seal same. Motion prevailed by the following vote : Ayes, Mayor Yett, Councilmen Alford, Graham, Haynes and Ward, 5; naves, none.
