BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That as said property was owned by the University on January 1st, 1920, and is not taxable, the Assessor and Collector is hereby authorized 450

to cancel the assessment above referred to from his rolls and to take oredit for the amount of the taxes for 1920.
