# Memorandum To:

Mayor Cooksey called to order the special called meeting of the Council, noting the absence of Mayor Pro Tem Trevino.

A worksession was held with a joint meeting with the Ethics Commission. Another worksession was held on ratification and reaffirmation of the anti-lobbying provision applicability to the remaining Civic Center Selection Process.
