#### Memorandum To:

Mayor Cooksey called to order the meeting of the Council, noting the absence of Councilmember Carl-Mitchell.

## MINUTES APPROVED

the completion and occupancy of certain office buildings and restaurants designed to comply with the standards of Chapter 13-2. (5-0 Vote, Councilmember Urdy out of the room, Councilmember Carl-Mitchell absent)

The Council, on Councilmember Shipman's motion, Mayor Pro Tem Trevino's second, closed the public hearing, waived the requirement for three readings and finally passed an ordinance amending Chapter 13-2A, Section 5610 and 5625 to require adequate installation and maintenance of landscaping on commercial project sites. (5-0 Vote, Councilmember Urdy out of the room, Councilmember Carl-Mitchell absent)

#### Motion

The Council, on Councilmember Shipman's motion, Mayor Pro Tem Trevino's second, closed the public hearing, waived the requirement for three readings and finally passed an ordinance amending Chapter 13-2A, Sections 13-2A-1864, 13-2A-2627, 13-2A-2462, 13-2A-2652, 13-2A-2677 and 13-2A-2712 to define "Employee Recreation-Non-Profit" as a civic use type and permit such use in the DR, IP, MI, LI and R&D zoning districts.
