- b. Amending Chapter 13-2A, Section 2545 to modify the "W/LO" Warehouse/Limited Office district site development regulations by increasing the maximum impervious coverage from fifty to seventy percent; July 16, 1987 at 5:00 p.m.
- c. Amending Chapter 13-2A by adding and amending several sections to define "Retirement Housing (Large and Small site)" uses and establish minimum off-street parking requirements for such uses: July 16, 1987 at 5:00 p.m.
