ADVANCE FUNDING AGREEMENT AMENDMENT # 1

THIS AMENDMENT IS MADE BY AND BETWEEN the State of Texas, acting through the Texas Department of Transportation, hereinafter called the State, and the City of Austin, acting by and through its duly authorized officials hereinafter called the Local Government

WITNESSETH

WHEREAS, the State and the Local Government executed a contract on December 22, 2004, to effectuate their agreement to construct a left turn lane on FM 1826 at the proposed Alta Mira Subdivision, and

WHEREAS, it has become necessary to amend that contract,

NOW THEREFORE in consideration of the premises and of the mutual covenants and agreements of the parties nereto the State and the Local Government do agree as follows

AGREEMENT

Article 1. Description of Amended Items

Attachment A, Payment Provisions, is voided and replaced by the following:

The Local Government shall contribute a fixed amount of \$294,323.00 towards the total project cost to include construction bid items, construction engineering and inspection, administration and indirect costs. Any additional costs required to complete the project shall become the responsibility of the State. It is understood that the proposed improvements will be done by the State and the State will include only those items for the improvements as agreed upon with the Local Government. The total fixed amount shall be received by the State prior to any work done by the State

All other provisions of the original contract are unchanged and remain in full force and effect

Article 2. Signatory Warranty

The signatories to this amendment warrant that each has the authority to enter into this agreement on behalf of the organization they represent
