

REGULAR MEETING THURSDAY, JUNE 17, 2004

Invocation: Rev. Ricky Poe, Promiseland Church

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, June 17, 2004 in the Board Room at Lower Colorado River Authority Hancock Building, 3700 Lake Austin Boulevard.

Mayor Wynn called the Council Meeting to order at 10:25 a.m.

CONSENT AGENDA

The following items were acted on by one motion. No separate discussion or action occurred on any of the items. The consent items were approved on Council Member Alvarez' motion, Mayor Wynn's second on a 7-0 vote.

1. Approval of minutes from the meeting of June 10, 2004.

The minutes from the regular meeting of June 10, 2004 were approved.

Item 2 was pulled for discussion.

3. Approve an ordinance to authorize execution of a grant with Texas Commission on the Arts Special Initiative Program, Austin, Texas for the Cultural Arts Program; authorize the acceptance of grant funds of \$10,000 under that agreement; and to amend the Fiscal Year 2003-2004 Economic Growth and Redevelopment Services Office Special Revenue Fund of Ordinance No. 030909-01 to appropriate \$10,000 to that fund. (Funding is available from the Texas Commission on the Arts Special Initiative Program. The grant period is March 25 to August 31, 2004. A \$10,000 National Endowment for the Arts grant awarded in October 2003 qualifies as City matching funds.)

Ordinance No. 040617-03 was approved.

4. Approve execution of Amendment Number One (1) to the Interlocal Cooperation Agreement between the City of Austin and Travis County for the Summer Youth Employment Program revising budget and performance for the period October 1, 2003 through September 30, 2004. (Funding in the amount of \$203,630 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Health and Human Services Department. Funding in the amount of \$33,777 is available in the Fiscal Year 2003-2004 Approved Operating Budget for the Human

Resources Department. Funding in the amount of \$83,634 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Health and Human Services Department's Travis County Reimbursed Fund.) (Related Item 5)

The motion authorizing the execution of Amendment Number One was approved.

- Amend Ordinance No. 030909-01, the Fiscal Year 2003-2004 Operating Budget of the Health and Human Services Department's Travis County Reimbursed Fund by increasing revenue from Travis County in the amount of \$83,634, and increasing operating expenditures in the amount of \$83,634 for summer youth employment stipends. (Funding in the amount of \$83,634 in increased expense reimbursement revenue from Travis County.) (Related Item 4)

 Ordinance No. 040617-05 was approved.
- 6. Approve an ordinance amending Section 2-10-32 of the City Code to expand the jurisdictional boundaries of the Downtown Austin Community Court. (Recommended by the Council Judicial Committee.)

Ordinance No. 040617-06 was approved.

Items 7 and 8 were pulled for discussion.

9. Approve a resolution to authorize the fee simple acquisition of 2.359 acre tract of land out of the Jonathan Bittick Survey No. 50, said 2.359-acre tract being all of that certain tract of land (called 2.36 acres) conveyed to Rosailia Verna Moore by special warranty deed recorded in Volume 6518, Page 982, of the Deed Records of Travis County, Texas, locally known as 10224 Moores Bridge Road, from Rosailia Verna Moore for the Airport Noise Mitigation Program, in the amount of \$93,200 for the land and improvements and \$24,050.70 relocation benefits, plus closing costs and moving related expenses in the amount of \$10,000, for an amount not to exceed \$127,250.70. (Funding in the amount of \$127,250.70 is available in Fiscal Year 2003-2004 Amended Capital Budget of the Department of Aviation using airport funds and available Federal Aviation Administration (FAA) Grants.)

Resolution No. 040617-9 was approved.

- 10. Authorize the negotiation and execution of a Cooperative Agreement between the United States of America Commodity Credit Corporation and the City of Austin for the Farm and Ranch Lands Protection Program to continue the City's role in preserving land and protecting water quality in conjunction with the Open Space November 7, 2000 Bond Proposition 2.
 - The motion authorizing the negotiation and execution of a Cooperative Agreement was approved.
- 11. Adopt an ordinance amending Sections 14-11-1 and 14-11-2 of the existing Code to allow preexisting improvements to remain in acquired easements without the necessity of securing a license agreement and to require field notes and a survey in all applications for license agreements.

Ordinance No. 040617-11 was approved.

12. Authorize execution of a construction contract with AARON CONCRETE CONTRACTORS, LP, (35.21% MBE/MH), Austin, TX, for the Nuckols Crossing Road Street Reconstruction and Utility Adjustment project in the amount of \$1,780,216 plus a \$89,010.80 contingency, for a total contract amount not to exceed \$1,869,226.80. (Funding in the amount of \$1,161,381.80 is available in the Fiscal Year 2000-2001 and in the Fiscal Year 2003-2004 Amended Capital Budget of the Public Works Department; funding in the amount of \$515,083.85 is included in the Fiscal Year 2003-2004 Capital Budget of the Austin Water Utility; and \$192,761.15 is available in the Fiscal Year 2000-2001 Amended Capital Budget of the Transportation, Planning and Sustainability Department.) Lowest bid of one received. 5.92% MBE and 55.36% WBE subcontractor participation.

The motion authorizing the execution of a construction contract was approved.

13. Authorize execution of a construction contract with RODRIGUEZ BARR, INC. dba THE BARR COMPANY AIA, (MBE/FH 91.71%), Austin, TX, for Austin-Bergstrom International Airport (ABIA) Terminal Improvements Phase 2 Base Bid in the amount of \$1,320,000 and Alternate Bids 1 and 2 that total \$25,900 plus a \$134,000 contingency, for a total contract amount not to exceed \$1,479,900. (Funding in the amount of \$1,479,900 is available in the Fiscal Year 2003-2004 Amended Capital Budget of the Department of Aviation.) Lowest bid of four received. 2.81% MBE and 5.48% WBE subcontractor participation.

The motion authorizing the execution of a construction contract was approved.

14. Authorize execution of change order # 10 to the construction contract with CADENCE MCSHANE CORPORATION, Austin, TX, for additional steel material and installation, for the George Washington Carver Museum and Cultural Center and Carver Branch Library Expansion, in the amount of \$53,476, for a total contract amount not to exceed \$10,470,432.61.(Funding in the amount of \$995 is available in the Fiscal Year 2003-2004 Approved Capital Budget of Library Department; and funding in the amount of \$52,481 is available in the Fiscal Year 2003-2004 Approved Capital Budget of the Parks and Recreation Department.) 22.02% MBE and 7.05% WBE subcontractor participation to date including this change order.

The motion authorizing the execution of change order #10 was approved.

15. Authorize execution of a 12-month supply agreement with GENERAL ELECTRIC SUPPLY, Austin, TX, for street light lamps in an amount not to exceed \$78,305.70, with two 12-month extension options in an amount not to exceed \$78,305.70 per extension option, for a total agreement amount not to exceed \$234,917.10. (Funding in the amount of \$26,101.92 is available in the Fiscal Year 2003-2004 Amended Operating Budget of the Electric Utility Department. Funding for the remaining eight months of the original contract period and extension options is contingent upon available funding in future budgets.) Lowest bid of eighteen bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a supply agreement was approved.

16. Authorize execution of a 12-month service and supply agreement with US FILTER, INCORPORATED, Conroe, TX, for the lease and operation of water treatment equipment in an amount not to exceed \$150,000, with three 12-month extension options in an amount not to exceed \$150,000 per extension option, for a total agreement amount not to exceed \$600,000. (Funding in the amount of \$37,500 is available in the Fiscal Year 2003-2004 Amended Operating Budget of the Electric Utility Department. Funding for the remaining nine months of the original contract period and extension options is contingent upon available funding in future budgets.) Low bid of five bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a service and supply agreement was approved.

17. Authorize execution of a contract with TECHLINE, INC., Austin, TX, for the purchase of a power cable system in an amount not to exceed \$823,550. (Funding is available in the Fiscal Year 2003-2004 Approved Capital Budget of the Electric Utility Department.) Lowest bid meeting specifications of three bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a contract was approved.

18. Authorize execution of a contract through the Texas Local Government Purchasing Cooperative (BuyBoard) with CUES, INC., Orlando, FL, for the purchase of three television inspection vans for the Austin Water Utility in an amount not to exceed \$277,560. (Funding in the amount of \$277,560 is available in the Fiscal Year 2003-2004 Amended Operating Budget of the Austin Water Utility. Funding in the amount of \$125,000 is from a grant from CH2M Hill, Inc. for the purchase of maintenance equipment to benefit the Austin Clean Water Program.) Purchasing Cooperative.

The motion authorizing the execution of a contract was approved.

19. Authorize execution of a 12-month supply agreement with SHERWIN-WILLIAMS CO., Austin, TX, for airport traffic striping paint in an amount not to exceed \$55,492.50, with two 12-month extension options in an amount not to exceed \$55,492.50 per extension option, for a total agreement amount not to exceed \$166,477.50. (Funding in the amount of \$18,497.50 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Aviation Department. Funding for the remaining eight months of the original contract period and extension options is contingent upon available funding in future budgets.) Lowest bid of five bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a supply agreement was approved.

20. Authorize execution of a 12-month service agreement with AARON CONCRETE CONTRACTORS, LP, (MBE/MH-100%), Austin, TX, for milling services for the Public Works Department in an amount not to exceed \$78,475, with two 12-month extension options in an amount not to exceed \$78,475 per extension option, for a total agreement amount not to exceed \$235,425. (Funding in the amount of \$19,618 is available in Fiscal Year 2003-2004 Approved Operating Budget of the Public Works Department. Funding for the remaining nine months of the original contract period and extension options is contingent upon available funding in future budgets.) Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a service agreement was approved.

21. Authorize execution of 12-month service agreement with RDO EQUIPMENT COMPANY, Austin, TX, for rental of a motor grader for the Solid Waste Services Department in an amount not to exceed \$54,000, with two 12 -month extension options in an amount not to exceed \$54,000 per extension option, for a total agreement amount not to exceed \$162,000. (Funding in the amount of \$13,500 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Solid Waste Services Department. Funding for the remaining nine months of the original contract period and extension options is contingent upon available funding in future budgets.) Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a service agreement was approved.

- 22. Authorize execution of a contract with SOMERSET WELDING & STEEL, INC. T/A J&J TRAILERS, Somerset, PA, for the purchase of six 31 cubic yard hydraulic ejection semi-trailers in an amount not to exceed \$247,098. (Funding is available in the Fiscal Year 2003-2004 Approved Capital Budget of the Solid Waste Services Department.) One bid received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.
 - The motion authorizing the execution of a contract was approved.
- 23. Authorize execution of a contract through the State of Texas, Texas Building and Procurement Commission, with HAWORTH INCORPORATED, Austin, TX, and its authorized distributor FURNITURE MARKETING GROUP, Austin, TX, for the purchase and installation of modular office systems for built-in cubicle arrangements including wall panels, desk tops, and cabinets in an amount not to exceed \$1,300,961.77. (Funding in the amount of \$673,000 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Watershed Protection and Development Review Department, Drainage Utility Fund. Funding in the amount of \$627,961.77 is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Financial Services Department, One Texas Center Fund.) Purchasing Cooperative. (Related Item 24)

The motion authorizing the execution of a contract was approved.

- 24. Authorize execution of a contract through the U.S. COMMUNITIES GOVERNMENT PURCHASING ALLIANCE with HAWORTH INCORPORATED, Austin, TX, and its authorized distributor Furniture Marketing Group, Austin, TX, for the purchase and installation of moveable wall panels/doors, office chairs and keyboard trays for the relocation of City offices from lease space to the One Texas Center in an amount not to exceed \$161,417.24. (Funding is available in the Fiscal Year 2003-2004 Approved Operating Budget of the Financial Services Department, One Texas Center Fund.) Purchasing Cooperative. (Related Item 23) The motion authorizing the execution of a contract was approved.
- 25. Ratify legal services contract with CROWELL & MORING, L.L.P., Washington, DC, for legal services related to the filing of claims in the United States District Court for the District of Columbia, to recover an increase in the Medicare Cost Report reimbursement amounts for Brackenridge Hospital for Fiscal Years ended 1992, 1993, and 1994, in an amount equal to ten percent (10%) of the total reimbursement amount. This contract was awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. (Related Item 26)

The motion authorizing the legal services contract was approved.

- 26. Ratify a consulting services contract with LANDMARK REIMBURSEMENT, Spring, TX, for services to document claims needed to obtain an increase in the Medicare Cost Report reimbursement amount for Brackenridge Hospital for Fiscal Years ended 1992, 1993, and 1994, in an amount equal to twenty percent (20%) of the total reimbursement amount. This contract was awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. (Related Item 25) The motion authorizing a consulting services contract was approved.
