# AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 1212 WEST BEN WHITE BOULEVARD FROM LIMITED OFFICE (LO) DISTRICT, GENERAL OFFICE (GO) DISTRICT, AND COMMUNITY COMMERCLAL (GR) DISTRICT TO COMMUNFY COMMERCIAL-MIXED USE-CONDITIONAL . OVERLAY (GR-MU-CO) COMBINING DISTRICT. 

## BE FT ORDAINED BY THE CITY COUNCIL OF THE CHYY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from limited office (LO) district, general office (GO) district, and community commercial (GR) district to community commercial-mixed use-conditional overlay (GR-MU-CO) combining district on the property described in Zoning Case No. C14-05-0197SH, on file at the Neighborhood Planning and Zoning Department, as follows:

A 2.52 acre ( 110,741 square feet) tract of land, more or less, out of Lot B, KRT Addition, in the City of Austin, the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),
locally known as 1212 West Ben White Boulevard, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "B".

PART 2. The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:

1. A site plan or building permit for the Property may not be approved, released, or issued, if the completed development or uses of the Property, considered cumulatively with all existing or previously authorized development and uses, generate traffic that exceeds 2,000 trips per day.
2. The following uses are prohibited uses of the Property:

> Automotive rentals
> Automotive sales Pawn shop servicés

Automotive repair services
Automotive washing (of any type)
Service station

Except as specifically restricted under this ordinance, the Property may be developed and used in accordance with the regulations established for the community commercial (GR) base district and other applicable requirements of the City Code.
