1 AN ORDINANCE WAIVING CERTAIN REQUIREMENTS IN CHAPTER 14-8  
2 OF THE CODE, CERTAIN FEES AND CHARGES, AND AUTHORIZING  
3 PAYMENT OF CERTAIN COSTS FOR THE GREATER EAST AUSTIN YOUTH  
4 ASSOCIATION'S 2006 PRE-JUNETEENTH PARADE AND FESTIVAL TO BE  
5 HELD JUNE 16, 2006.

7 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

9 **PART 1.** The Council waives the requirements in City Code Sections 14-8-12 (*Security*  
10 *Deposit Required*), 14-8-16 (*Notice of Proposed Closure and Signature Requirement*),  
11 and 14-8-17 (*Calculation of Required Signatures; Request for Reduction*) for the Greater  
12 East Austin Youth Association's 2006 Pre-Juneteenth Festival and Parade to be held June  
13 16, 2006.

14 **PART 2.** The Council waives the following fees and charges in connection with the  
15 Greater East Austin Youth Association's 2006 Pre-Juneteenth Parade and Festival. Fees  
16 that have been paid shall be reimbursed.
