This action appoints Michael C. McDonald as director and President of the Arbors at Creekside Non-Profit Corporation for a term expiring January 1, 2007; Kelly Weiss and Diana Domeracki as Directors of the Corporation for terms expiring January 1, 2007; and reappoints Paul Hilgers and Martin Gonzalez as Directors of the Corporation for terms expiring January 1, 2008 to carry out the functions of General Partner of Arbors Housing Partners, Ltd., a partnership that owns the Primrose of Shadow Creek. In accordance with the bylaws of the Corporation the President and board members are appointed by the Austin Housing Finance Corporation (AHFC) Board.

The Primrose of Shadow Creek is an independent living facility for seniors over 55 with incomes below 60% of median family income located at 1026 Clayton Lane. The project was financed with AHFC issued bonds and 4% Low Income Housing Tax Credits and is comprised of 160 one and two bedroom units. Rents range between \$550 and \$652 per month.
