MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will supply ten transformer bushings. Bushings are insulating devices used on transformers, switchgear and circuit breakers. Bushings connect the high voltage wires from the substation bus to a specific piece of equipment while maintaining the appropriate clearances to prevent sparking. Austin Energy will use these bushings as replacements for existing bushings when performing routine testing on substation transformers.
