SUBJECT: Authorize execution of a 12-month supply agreement with BACOU-DALLOZ PROTECTIVE APPAREL, LTD., Montreal, Quebec, Canada, for the purchase of fire fighting bunker coats and pants for use by the Austin Fire Department in an amount not to exceed \$260,543,52, with two 12-month extension options in an amount not to exceed \$260,543.52 per extension option, for a total agreement amount not to exceed \$781,630.56.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$195,407.54 is included in the Fiscal Year 2005-2006 Approved Operating Budget of the Austin Fire Department. Funding for the remaining three months of the original contract period and extension options is contingent upon available funding in future budgets.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract establishes a reliable source for the annual supply of bunker coats and pants worn by fire fighting personnel to provide protection during structural fire fighting operations or where there is a threat of fire. It is also necessary to provide bunker gear to protect fire fighters when certain physical hazards are likely to be encountered; such as during non-fire related rescue operations, emergency medical operations, and/or victim extrication. The bunker gear is made of fire and moisture retardant material known as Nomex and Keylar and is designed to protect the fire fighter from heat and flame during fire fighting operations.

- a. Adequate competition.
- b. Thirty notices were sent, including one MBE and three WBEs. Five solicitations were issued. Four bids were received with no MBEs/WBEs responding. One "No Bid" was received.
- c. The pricing offered represents an approximate 18% increase in the unit price from the last contract awarded October 2003. This is due to specification changes and market increases. The specification changes include bunker gear to be manufactured with a "drag rescue device". This device allows an injured firefighter to be dragged by a fellow firefighter by a ring that is manufactured into the jackets and pants.
