On October 6, 2005, City Council authorized the purchase of the Emerson Process Management campus at 8301 Cameron Road. The site will house several City departments that are currently in lease space.

Through this contract, the existing modular furniture, purchased with the building, will be disassembled, inventoried and stored on-site by Furniture Marketing Group (FMG) while building renovations are underway. FMG will reconfigure and re-install the modular furniture as needed to accommodate approximately 700 office cubicles.
