<u>SUBJECT:</u> Set a public hearing to consider a request for a waiver from the minimum distance requirement of City Code Section 4-9-4(A) which requires 300 feet between a proposed business that will sell alcoholic beverages at 4800 Burnet Road and a public school, Texas School for the Blind and Visually Impaired, at 1100 West 45th Street. (Suggested date and time: January 12, 2006 at 6:00 p.m., City Hall Council Chambers, 301 West 2nd Street.)

The owner of Sampaio's Restaurant, Magna Sampaio, requests a waiver from the minimum distance requirement of 300 feet in Section 4-9-4(A) of the Austin City Code because she intends to sell alcoholic beverages at her restaurant which is located 81 feet from a public school, Texas School for the Blind and Visually Impaired, at 1100 W. 45th Street.

Section 4-9-5 allows the City Council to waive the 300 foot distance requirement if they determine that enforcement of the distance requirement in a particular instance:

- (1) is not in the best interest of the public;
- (2) constitutes waste or the inefficient use of land or other resources;
- (3) creates an undue hardship on an applicant;
- (4) does not serve its intended purpose;
- (5) is not effective or necessary; or
- (6) for any other reason the council, after consideration of the health, safety, and welfare of the public and the equities of the situation, determines is in the best interest of the community.

Section 4-9-5(B) provides that the City Council may consider a written consent to the waiver of the 300 foot distance requirement provided by each church, public school, public hospital, day-care center or child-care facility within 300 feet of the proposed place of business to be sufficient justification for the waiver. Written consent to allow the waiver has been received from Dr. Phil Hatlen, Superintendent of Texas School for the Blind and Visually Impaired.


<u>**REOUEST</u>:** The applicant, Magna Sampaio, requests a waiver from the minimum distance requirement of 300 feet in Section 4-9-4(A) of the Austin City Code. Ms. Sampaio is proposing selling alcoholic beverages at her restaurant, which is located 81 feet from the Texas School for the Blind and Visually Impaired.</u>

Section 4-9-5(A) allows the City Council to waive the 300 foot distance requirement if they determine that enforcement of the distance requirement in a particular instance:

- (a) is not in the best interest of the public;
- (b) constitutes waste or the inefficient use of land or other resources;
- (c) creates an undue hardship on an applicant
- (d) does not serve its intended purpose
- (e) is not effective or necessary; or
- (f) for any other reason the City Council, after consideration of the health, safety, and welfare of the public and the equities of the situation, determines is in the best interest of the community.

Section 4-9-5(B) provides that the City Council may consider a written consent to the waiver of the 300-foot distance requirement provided by each church, public school, public hospital, day-care center of child-care facility within 300 feet of the proposed place of business to be sufficient justification for the waiver. The superintendent for the Texas School for the Blind and Visually Impaired, Phil Hatlen, has provided a letter indicating he is in support of the request.

Staff recommends approval of the waiver request.

If you are not providing this service already, I ask in return that you Braille menus available for blind customers.


