<u>MBE / WBE:</u> This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will provide for one 145kV, 25kA circuit switcher to be replaced at the Jollyville Substation. Circuit switchers are designed to provide switching and protection to Austin Energy's large power transformers and capacitor banks. The switch can be operated either locally or by remote control to disconnect equipment from the power system for maintenance purposes. It can also be automatically operated by power system protection schemes when an overload or short-circuit condition is detected, thus protecting equipment from excessive current.

- c. The pricing offered represents a 9% increase from the last contract awarded October 2003.
