Section 25-10-1 of the City Code provides for the City's authority to regulate signs within the City's planning jurisdiction. This authority requires that all signs within the Austin city limits and its extraterritorial jurisdiction comply with Chapter 25-10 SIGN REGULATIONS of the City Code.

The purpose of the proposed amendment is to ensure that signs for any future commercial development along the portion of State Highway 130 (SH 130) that lie within the City's planning jurisdiction are regulated under the provisions of City Code 25-10-124 SCENIC ROADWAY SIGN DISTRICT REGULATIONS. This section provides regulations for the number of freestanding signs allowed, sign height and sign area limits, lighting restrictions, and setback requirements.

The proposed amendment will also ensure that off-premise signs are regulated under the provisions of Section 25-10-152 NONCONFORMING SIGNS of the City Code. By including SH 130 to the list of Scenic Roadways, it would prohibit the relocation of an off-premise sign to the portion of SH 130 that is within the City of Austin's planning jurisdiction.

AN ORDINANCE AMENDING SECTION 25-10-6 OF THE CITY CODE TO ADD STATE HIGHWAY 130 AS A SCENIC ROADWAY; AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 25-10-6 (Scenic Roadways Described) of the City Code is amended to read:

§ 25-10-6 SCENIC ROADWAY'S DESCRIBED.

The following are scenic roadways:

- (1) Arterial 8 (Adelaide Drive/Forsythia Drive);
- (2) Barton Springs Road;
- (3) Loop 1 (MoPac);
- (4) Loop 360 (Capital of Texas Highway), south of US 183;
- (5) RM 620, from SH 71 to Anderson Mill Road (FM 2769);
- (6) RM 2222, west of MoPac only;
- (7) RM 2244;
- (8) Lake Austin Boulevard;
- (9) West Cesar Chavez Street;
- (10) Riverside Drive;
- (11) Spicewood Springs Road, from Mesa Drive to Loop 360;
- (12) William Cannon Drive, from Brodie Lane to Southwest Parkway;
- (13) Escarpment Boulevard, from William Cannon Drive to Arterial 11 (SH 45);
- (14) Arterial 5 (McKinney Falls Parkway) from US 183 to William
