On October 6, 2005, Council approved a budget of \$22,125,000 to purchase commercial property at 8301 Cameron Road and to complete renovations to make the site suitable for occupancy by various City departments. The purchase was completed on January 3, 2006.

Solid Waste Services, presently housed in leased space, will be a major tenant of the Cameron Road site and the first of several City departments to re-locate to this property. Solid Waste Services is expected to occupy the space in mid-April 2006.

This contract is for the purchase and installation of approximately 2,435 square yards of flooring. The contract also provides for removing and recycling the existing (and badly worn) flooring and installing new cove base throughout the future Solid Waste Services space.

Another flooring contract is expected to be brought to Council later this spring as space planning for other tenants at the Cameron site is completed.
