This contract is for the purchase of six walk-behind vibratory rollers that will be assigned to the Street & Bridge Division of the Public Works Department for use in road repair projects throughout the City. The rollers are used to compact asphalt used for permanent repairs to utility cut trenches, and level-ups for seal coating projects, as well as some temporary pavement repairs to Austin streets.

These rollers will replace six existing rollers that have met the Fleet Officer's eligibility criteria for replacement. Fleet Service Center Managers have inspected each roller to be replaced, and have determined that the useful life cannot be extended without risking significant increases in repair costs, and loss of productivity due to down time.

Hi-Way Equipment Company, Inc. is under contract with H-GAC to supply equipment statewide as a result of a competitive bidding process. Utilizing the H-GAC contract provides for volume discount pricing as well as the earliest delivery of the equipment.
