This contract will provide for the replacement of six cooling radiators to be used at the Holly Power Plant Unit 3 Transformer. Transformers use cooling radiators to cool the insulating oil of the transformer. As the load increases on the transformer, the core and coils become heated. The insulating oil in which the core and coil are immersed dissipates the heat when the oil is circulated through the radiators. A radiator failure would result in the transformer being removed from service, thereby making the Unit 3 generator not available for service.
