SUBJECT: Approve an ordinance to amend Section 12-4-63 of the City Code to establish a 20 miles per hour speed limit on Staked Plains Drive, Staked Plains Loop, Fletcher Hall Lane, Small Drive, and Spicewood Parkway.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$9,500 is available in the Fiscal Year 2005-2006 Operating Budget of the Public Works Department for the installation of necessary signs and two warning beacons.

The Transportation Division of the Public Works Department has completed an investigation on Staked Plains Drive, Staked Plains Loop, and Fletcher Hall Lane, adjacent to Rutledge Elementary School; on Small Drive, adjacent to St Theresa's School; and on Spicewood Parkway in the vicinity of Spicewood Elementary School. As a result of this investigation, the Transportation Division recommends adding the following to the City Code Section 12-4-63 (20 MPH School Zone).

Amendment to Code Section 12-4-63 (20 Miles Per Hour School Zones):

Add: Staked Plains Drive from Staked Plains Loop (east) to Staked Plains Loop (west). (Rutledge Elementary School)

Staked Plains Loop (east) from Hattery Lane to Misty White Drive. (Rutledge Elementary School)

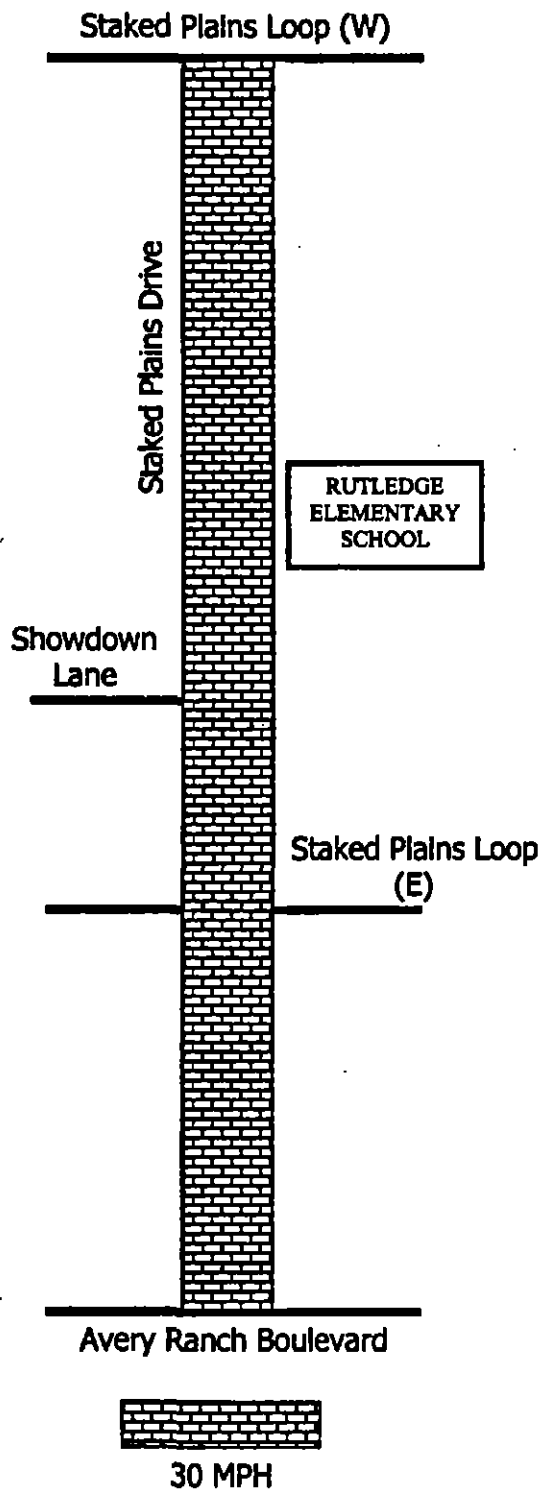
Staked Plains Loop (west) from Springs Head Loop to Misty White Drive. (Rutledge Elementary School)

Fletcher Hall Lane between Staked Plains Loop (east) and Staked Plains Loop (west). (Rutledge Elementary School)

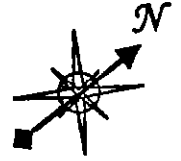
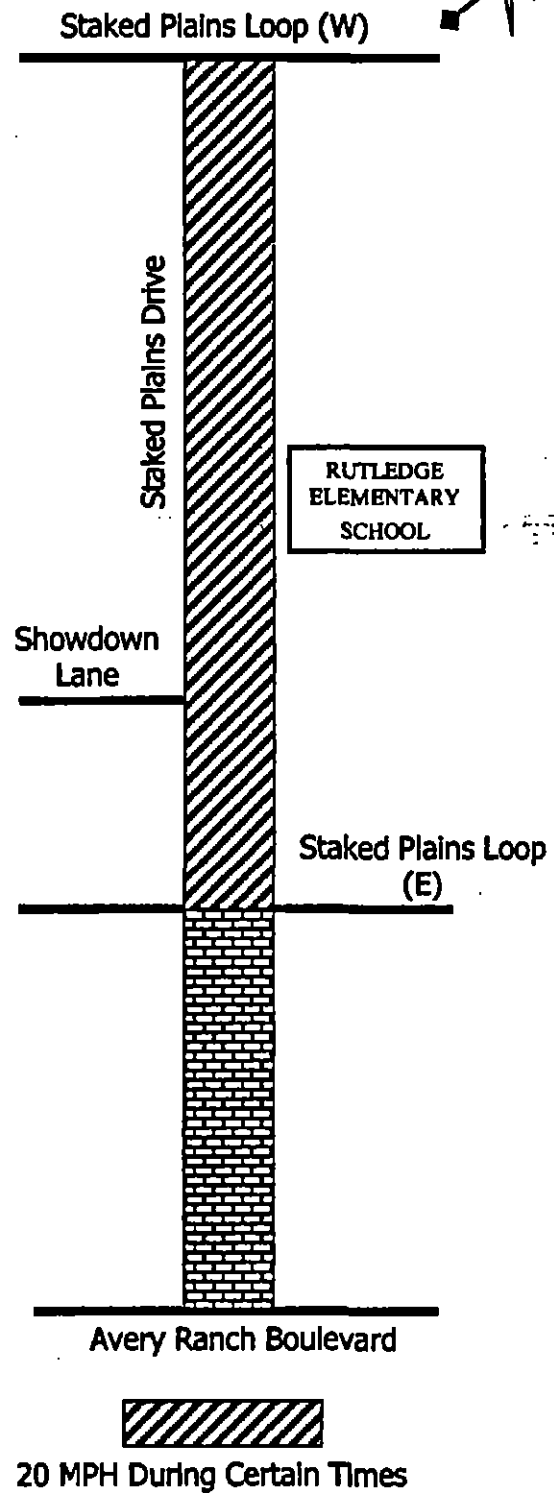
Small Drive from 207 feet east of Mt. Bonnell Road to 110 feet south of Cross Valley Run. (St. Theresa's School)

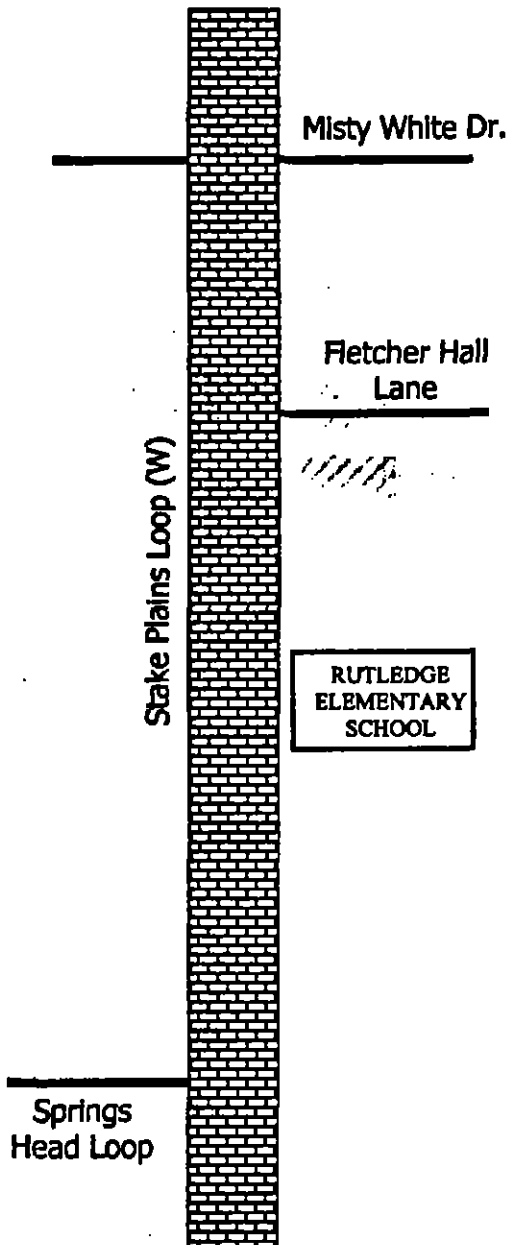

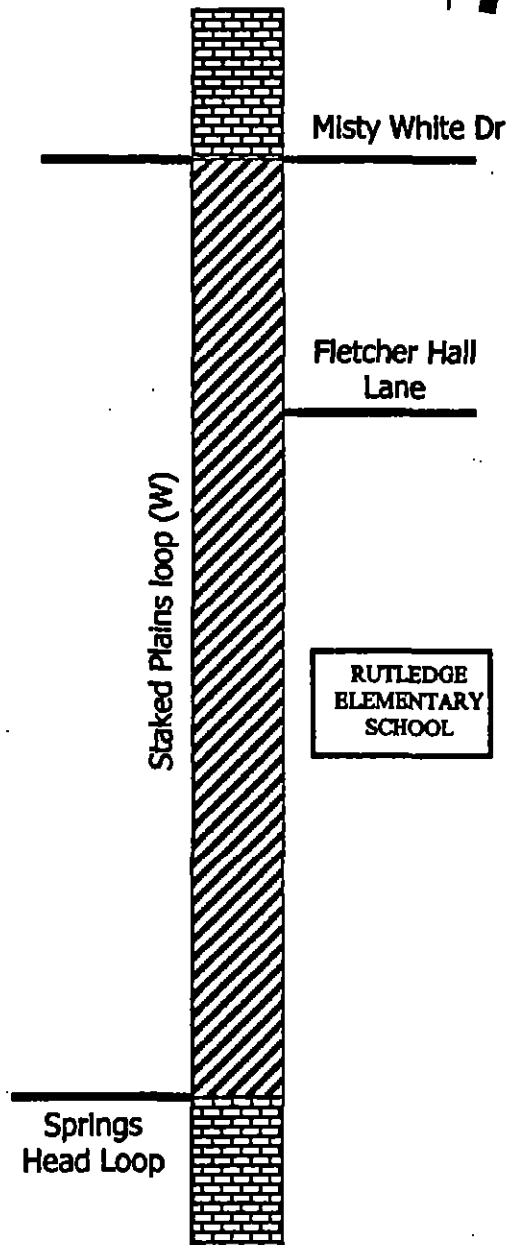

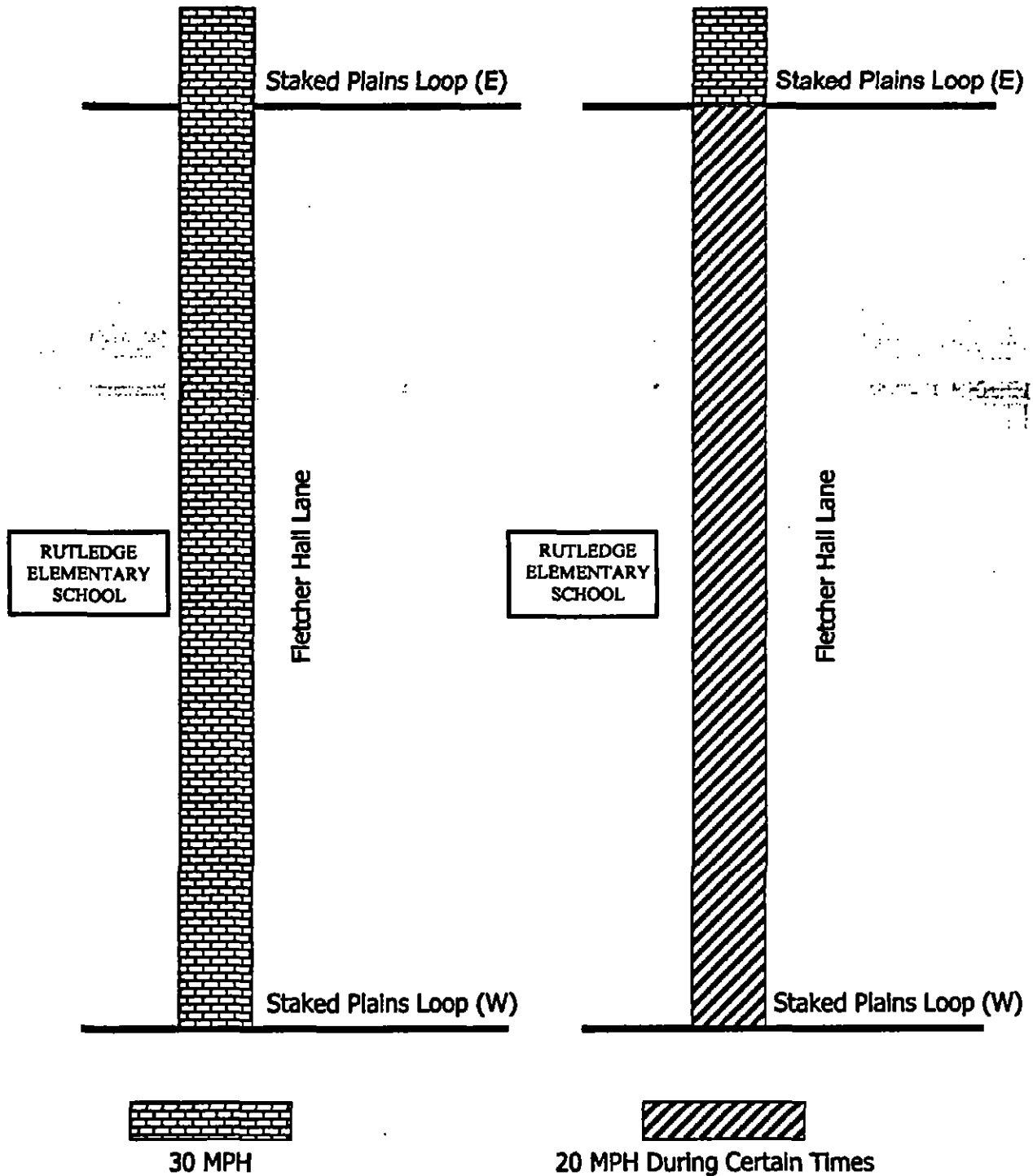

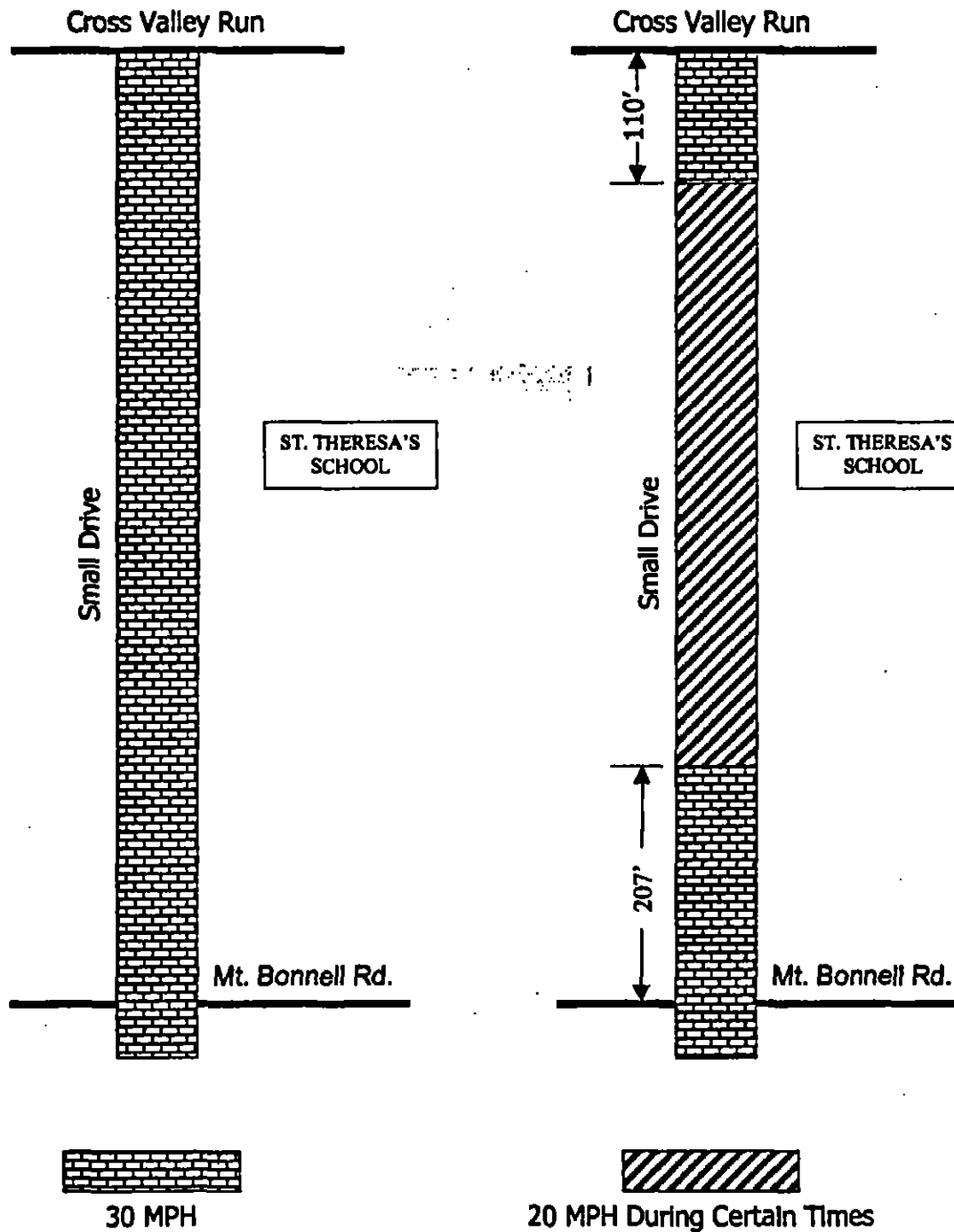

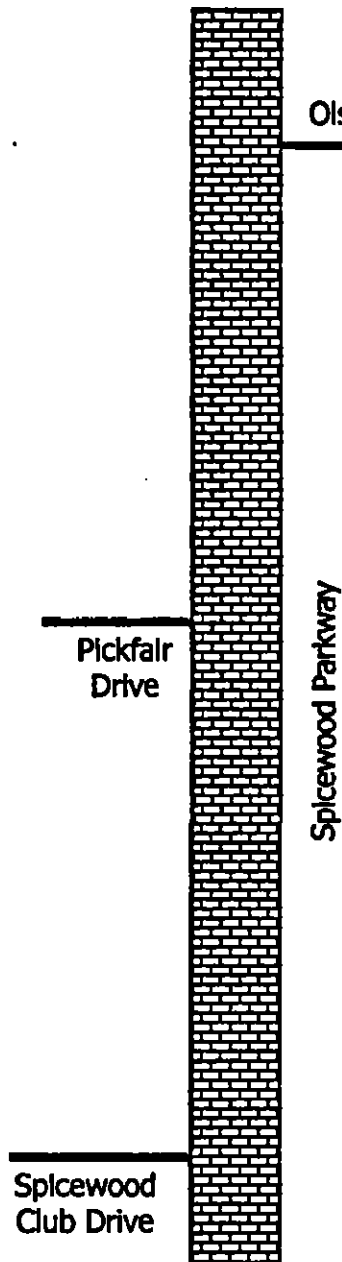

ORDINANCE NO.

AN ORDINANCE TO AMEND SECTION 12-4-63 OF THE CITY CODE BY ADDING PORTIONS OF STAKED PLAINS DRIVE, STAKED PLAINS LOOP, FLETCHER HALL LANE, SMALL DRIVE, AND SPICEWOOD PARKWAY TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 20 MILES PER HOUR IN A SCHOOL ZONE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-63 (*20 Mile Per Hour School Zones*) of the City Code is amended to add:

Staked Plains Drive from Staked Plains Loop (east) to Staked Plains Loop (west) (Rutledge Elementary School);

Staked Plains Loop (east) from Hattery Lane to Misty White Drive (Rutledge Elementary School);

Staked Plains Loop (west) from Springs Head Loop to Misty White Drive (Rutledge Elementary School);

Fletcher Hall Lane between Staked Plains Loop (east) and Staked Plains Loop (west) (Rutledge Elementary School);

Small Drive from 207 feet east of Mt. Bonnell Road to 110 feet south of Cross Valley Run (St. Theresa's School); and

Spicewood Parkway from Olson Drive to Spicewood Club Drive (Spicewood Elementary School).

PART 2. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.

PART 3. This ordinance takes effect on _____, 2006.
