The Davis Water Treatment Plant experienced a failure of one of the two 5ky electrical cables providing power to the raw water pumping station. Should the second line fail, the water system would lose the largest water plant in the system. The Davis Plant is a 120 million gallon per day facility, providing 47% of the total flow to the water system. This is the third electrical cable failure at this site in the past three years related to age. A project for the electrical improvements at this plant is projected to begin in 2008; however, this purchase was necessary due to the fact that the loss of this plant would pose an immediate risk to public safety and health.
