PART 1. The street name Liana Grove Lane is changed to Ava Lane to enhance the neighborhood as authorized in Section 14-5-4(8) of the City Code.

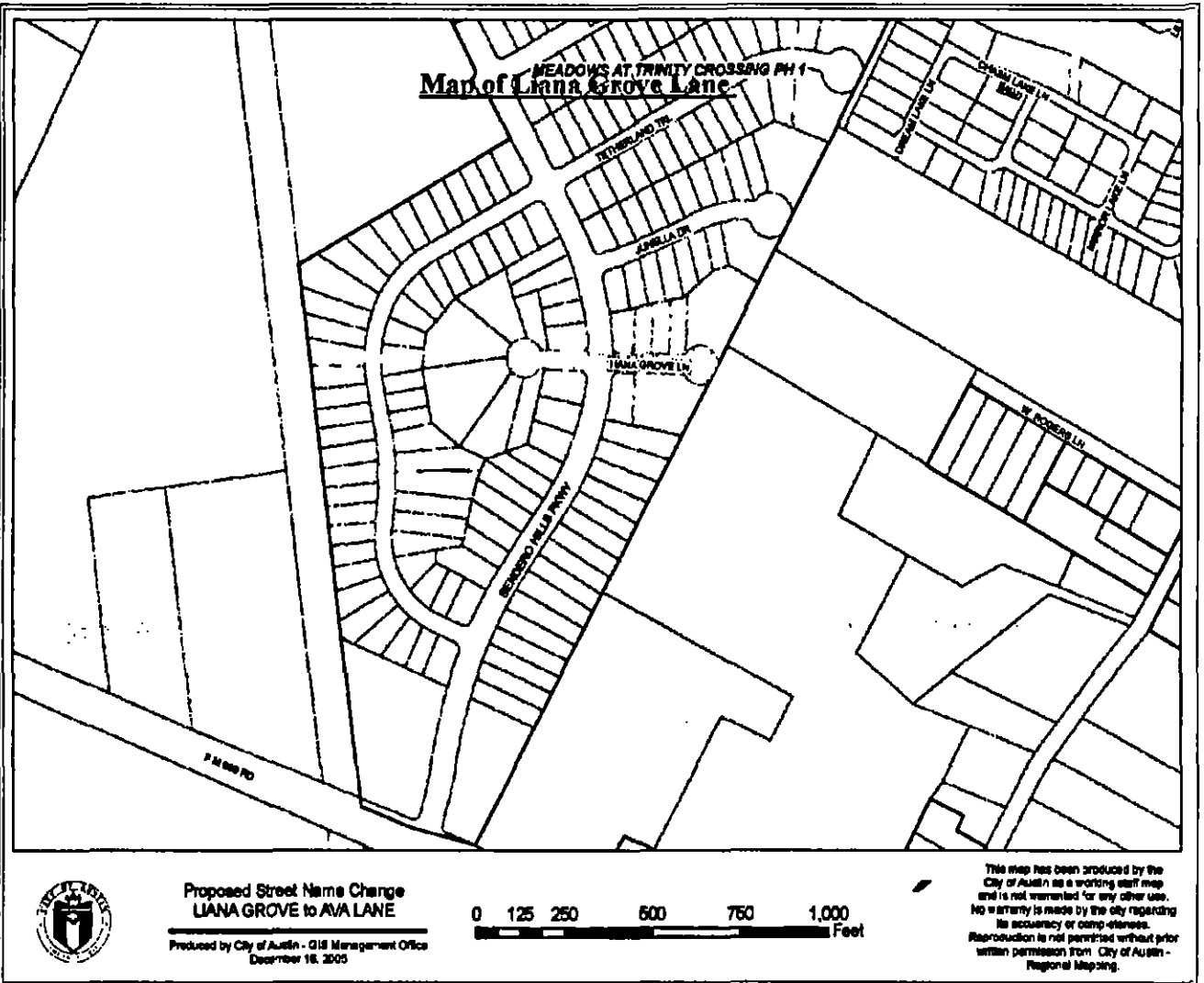
