PART 1. The street name Junella Drive is changed to Annette Cove to enhance the neighborhood as authorized in Section 14-5-4(8) of the City Code.

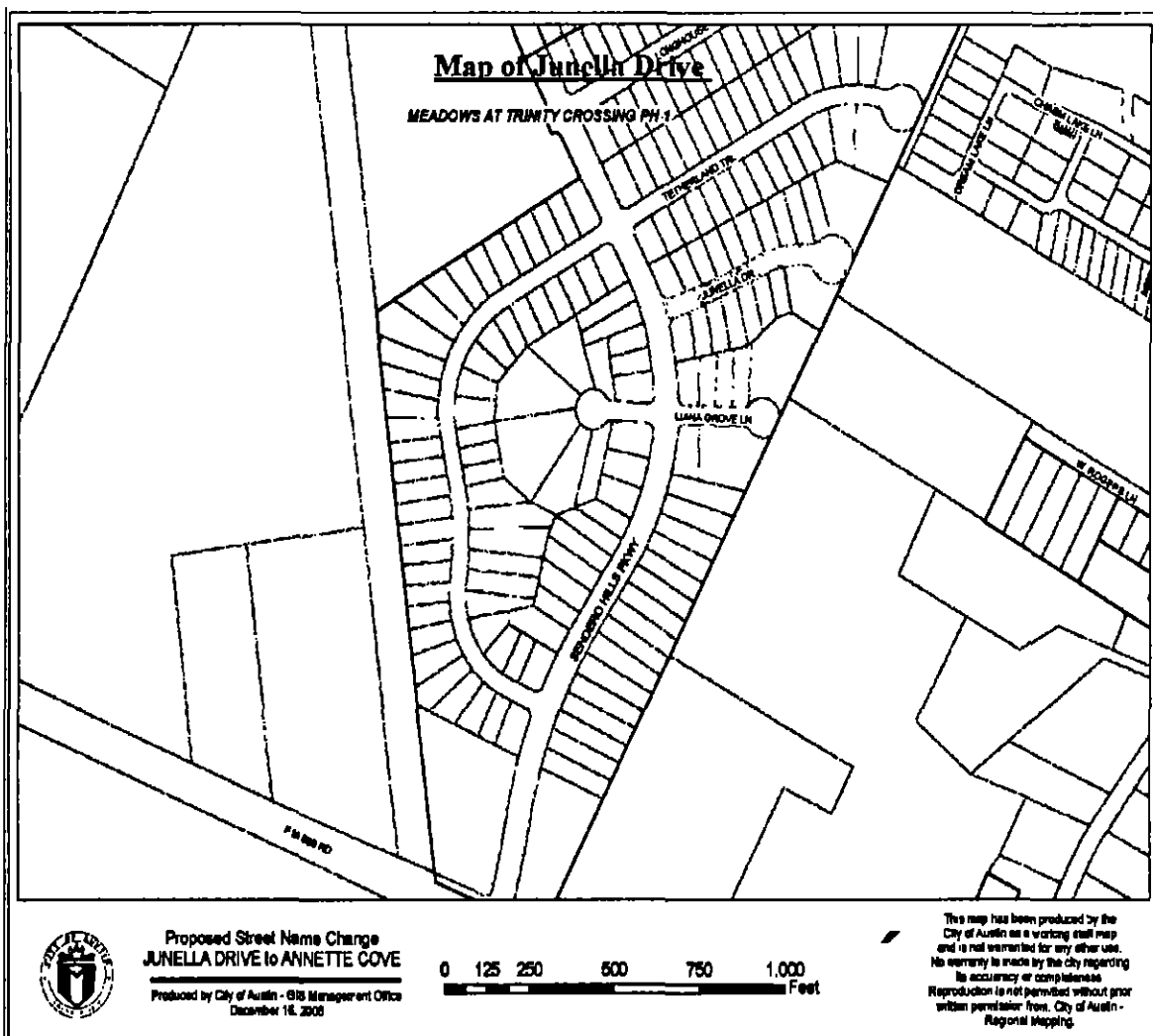
