This Interlocal Agreement will address the construction, maintenance and operation of a portion of the Lance Armstrong Bikeway in the area where the bikeway will traverse AISD property. The City of Austin will administer the construction contract and maintain the bikeway. AISD will allow the bikeway to cross their property.

The Lance Armstrong Bikeway begins on Veterans Drive at Lake Austin Boulevard and goes under MoPac and then south of the Stephen F. Austin High School on Stephen F. Austin Boulevard to Cesar Chavez Street. At Cesar Chavez Street the bikeway will be routed off the street onto AISD property to the Cesar Chavez - MOPAC ramp where it is routed on to the City of Austin right-of-way. This agreement sets forth the responsibilities and obligations of the AISD and the City of Austin. The City of Austin will agree to construct some speed humps and signage on Stephen F. Austin Boulevard for the purpose of traffic calming.
