<u>SUBJECT:</u> Approve a resolution authorizing the application for renewal grant funding from the State of Texas, Governor's Office, Criminal Justice Division, Victims of Crime Act in the amount of \$411,366 for eight full-time equivalent (FTE) Victim Counselors for a "Comprehensive Victim Services Program."

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$411,366 is available in the grant period of July 1, 2006 - June 30, 2007 from the State of Texas, Governor's Office, Criminal Justice Division. A match of \$198,082 will be met by 2 FTE positions and in-kind volunteers Victim Service counselor hours. The match can be found in the approved Fiscal Year 2006 Operating Budget of the Austin Police Department Victim Services Program.

This action approves a resolution authorizing the City to apply for \$411,366 in grant renewal funding from the State of Texas, Governor's Office, Criminal Justice Division, Victims of Crime Act (VOCA) for the Austin Police Department. A match of \$198,082 includes 2 FTE positions and in-kind volunteer Victim Service counselor hours. The grant funds a total of eight (8) FTEs to provide services for approximately 6,000 victims of crime. The goal of the grant program is to increase the number of primary and secondary crime victims receiving counseling and referral services during the initial stages of crisis, in following-up with adult crime victims, and in working with children witnessing or experiencing family, school and/or community violence. The grant period runs from July 1, 2006 – June 30, 2007.

The APD Victim Services Program positively impacts the quality of life for the citizens of Austin by assisting victims/survivors and their families who have experienced crime. These services will help them recover more quickly and completely from the effects of victimization. The eight (8) grant-funded FTE Victim Counselors provide on-scene crisis stabilization (Crisis Team) and investigative support and follow-up (Centralized Investigations and Family Violence) services.

This grant addresses the Department goal of reducing crime, fear of crime, and improving the quality of life of Austin's residents. It also addresses the following APD Program Objective: The purpose of the Victim Services Program is to respond to the psychological and emotional needs of victims/families, neighbors and community members experiencing crime and/or trauma so that they can recover more quickly and completely from the effects of victimization.
