<u>SUBJECT</u>: Authorize execution of a construction contract with OSCAR RENDA CONTRACTING, INC., Roanoke, TX for the Austin Clean Water Program: Downtown/White Horse Trail Wastewater Improvements Project, Phase I, in the amount of \$3,271,885 plus a \$20,000 incentive bonus and a \$327,185 contingency, for a total contract amount not to exceed \$3,619,035.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$3,619,035 is included in the Fiscal Year 2005-2006 Capital Budget of the Austin Water Utility.

This construction contract will provide for the installation of new wastewater pipelines generally located in Downtown Austin, south of 10<sup>th</sup> Street, west of Trinity Street, north of Cesar Chavez Street, and east of San Antonio Street. The project will consist of five distinct project locations. Streets to be impacted by construction include: Cesar Chavez Street from west of Brazos Street to west of Congress Avenue, Cesar Chavez Alley from Trinity Street to Brazos Street, 3<sup>rd</sup> Street from San Antonio Street to Lavaca Street, 9<sup>th</sup> Street from Nueces Street to Guadalupe Street, 9<sup>th</sup> Street Alley from Colorado Street to Lavaca Street, and Guadalupe Street from 2<sup>nd</sup> Street to 3<sup>rd</sup> Street. The improvements are intended to replace aging and deteriorated facilities and eliminate wastewater overflows that have occurred in these areas. The project is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows.

The proposed wastewater line improvements include the installation of 576 feet of 24-inch wastewater line, 832 feet of 12-inch wastewater line, 1,813 feet of 8-inch wastewater line, and 445 feet of 6- and 12-inch water line. A total of 33 new manholes will be installed the project.

The project will consist of 24-hour lane closures at three of the five project sites. The most significant of the three closures is at Cesar Chavez Street, half a block east of Congress Avenue in front of the Radisson Hotel. Currently, Cesar Chavez Street is comprised of two eastbound through lanes and two left turn lanes from Congress Avenue. This project will require the closure of the two eastbound through lanes and the temporary straightening of one turn lane, with the final turn lane to remain in place. However, traffic will be allowed to flow normal beginning at Brazos Street on Cesar Chavez Street. Lane closures are necessary for the construction of a tunnel shaft at Cesar Chavez Street just east of Congress Avenue.

The proposed contract stipulates that a maximum of 70 calendar days are allowed for the contractor to construct the proposed line before liquidated damages begin to accrue at \$1,333.00 per day. However, in an effort to fast-track construction at this location, the contract allows for an incentive of \$1,000 per day for a not-to-exceed total of \$20,000. This incentive was included in the contract in order to minimize impact to the traveling public in the Central Business District as well as to complete the utility work prior to the planned Cesar Chavez Two-way Conversion Project.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-of-way, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 290 calendar days for substantial completion and another 45 calendar days for final completion of this project.

Bid documents were distributed to 9 general contractors. Bids were opened on February 14, 2006. The low bidder, Oscar Renda Contracting, Inc. submitted the lower of 2 bids received:

The contractor's choice of work methodology provides for subcontracting opportunities in 8 areas which are listed below. Participation subgoals stated in the solicitation were 7.74% African American (MB); 10.32% Hispanic (MH); 0% Native American (MN); 0.42% Asian Americans (MA); 7.02% WBE. 
