AN ORDINANCE AMENDING ORDINANCE NO. 20060302-035 RELATED TO THE BUDGETS OF THE CITY AUDITOR AND THE AUSTIN CONVENTION CENTER TO STATE THE CORRECT FISCAL YEAR.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The caption of Ordinance No. 20060302-035 is amended to read as follows:

AN ORDINANCE AMENDING THE FISCAL YEAR <u>2005-2006</u> [2006-2007] OFFICE OF THE CITY AUDITOR AND THE AUSTIN CONVENTION CENTER OPERATING BUDGETS OF ORDINANCE NO. 20050912-001 FOR EXPENSES RELATED TO HOTEL OCCUPANCY TAXES.

PART 2. Part 1 of Ordinance No. 20060302-035 is amended to read as follows:

PART 1. The Council amends the Fiscal Year <u>2005-2006</u> [2006-2007] Office of the City Auditor Operating Budget of Ordinance No. 20050912-001 to increase appropriations and expenditures by an amount of \$50,000 and increase reimbursements from the Austin Convention Center by an amount of \$50,000.

PART 3. Part 2 of Ordinance No. 20060302-035 is amended to read as follows:

PART 2. The Council amends the Fiscal Year 2005-2006 [2006-2007] Austin Convention Center Operating Fund of Ordinance No. 20050912-001 to increase expenditures by an amount of \$50,000 and to reduce the ending balance by an amount of \$50,000.
