

Boards and Commission Action:

The Winfield MUD No. 2 Area (approximately 575 acres) is located in Travis County and Hays County approximately 1.5 miles east of South IH 35 and south of Turnersville Road.) The proposed land use for Winfield MUD No. 2 includes office and industrial development. This area is being annexed in accordance with the terms of the Strategic Partnership Agreement (SPA) between the City of Austin and the Winfield MUD No. 2, approved on April 6, 2006.

AN ORDINANCE ANNEXING FOR THE LIMITED PURPOSES OF PLANNING AND ZONING ADDITIONAL TERRITORY ADJACENT TO THE CITY LIMITS OF THE CITY OF AUSTIN, CONSISTING OF APPROXIMATELY 575.70 ACRES OF LAND OUT OF THE WILLIAM PORTER SURVEY NO. 6, THE GEORGE HERDER SURVEY NO. 537 AND THE HENRY DOWMAN SURVEY NO. 536 IN TRAVIS AND HAYS COUNTIES, TEXAS, AND REFERRED TO AS THE "WINFIELD MUD NO. 2" AREA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council makes the following findings.

- (A) Notice of two public hearings concerning the limited purpose annexation of the territory described in Exhibit A, referred to as the Winfield MUD No. 2 Area, was published in a newspaper of general circulation in the City of Austin; in the area to be annexed; and on the City of Austin internet website.
- (B) A report containing a planning study and regulatory plan for the territory to be annexed was prepared more than 10 days before the first public hearing.
- (C) Notice of the availability of the report was published twice in a newspaper of general circulation in the area to be annexed.
- (D) The public hearings were held during City Council meetings, and concluded after providing an opportunity for all persons present to be heard with respect to the proposed annexation.
- (E) The Regulatory Plan, as amended by City Council, shall be approved by separate ordinance.
- (F) The limited purpose annexation of this territory serves the interests of the current and future residents of the City of Austin.
- (G) All procedural requirements imposed by state law for the limited purpose annexation of the territory described in Exhibit A have been met.

PART 2. The present boundary limits of the City are amended to include the territory described in Exhibit A for limited purposes. The territory is within the extraterritorial
