RECOMMENDATION FOR COUNCIL ACTION**

**Subject:** Approve a resolution to authorize the fee simple acquisition of Lot 7, Block K, Onion Creek Forest, Section 2, Amended Plat, a subdivision in Travis County, Texas, located at 5510 Vine Hill from Betty Jean Wilson James, Kenneth A. Wilson, Jr., and Gilbert Pinson and Beverly Pinson for the Onion Creek Flood Buyout Program in the amount of \$50,000 for the land and improvements, \$22,500 for owner-assisted relocation benefits plus moving related expenses not to exceed \$10,000, for a total amount not to exceed \$82,500.

**Amount and Source of Funding:** Funding in the amount of \$82,500 is included in the Fiscal Year 2005-2006 Capital Budget of the Watershed Protection and Development Review Department.

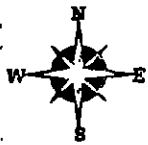

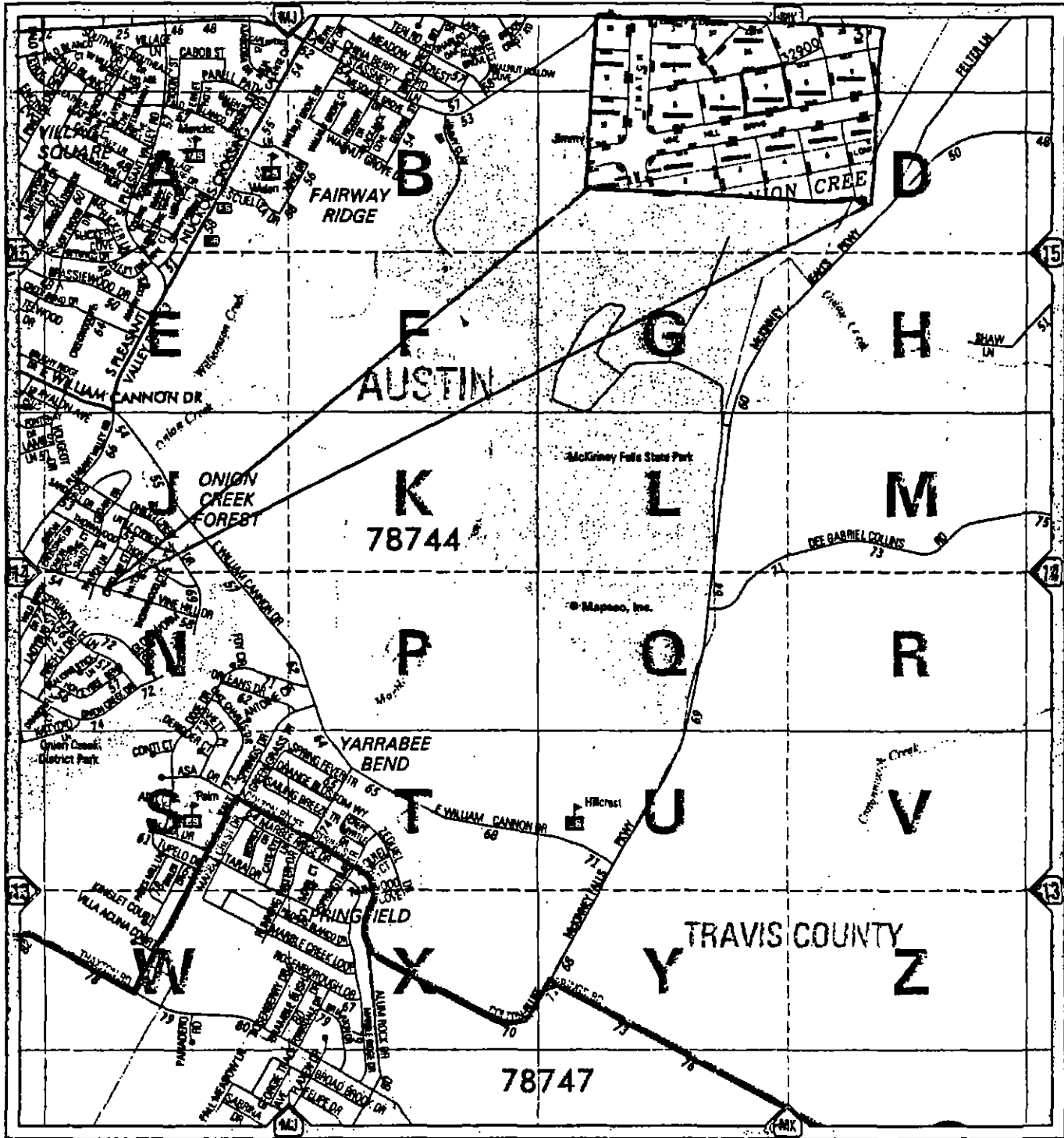
The property and residence located at 5510 Vine Hill Drive is part of the severe flooding of residential structures that occurred on October 17, 1998. There is an immediate need to proceed with the buyout transactions for the properties targeted for buyout in the Onion Creek Forest area of the Onion Creek Watershed.

The lot to be acquired is approximately 0.23 acres with improvements that include a 1,554 square foot single family dwelling (doublewide mobile home). The market value of the property including improvements is \$50,000, as determined by independent appraisal. The owner has agreed to accept the City's offer and is eligible for relocation expenses estimated to be \$22,500, plus moving related expenses not to exceed \$10,000. The City will relocate the owner according to the City of Austin Relocation Ordinance.

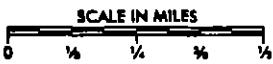
