RECOMMENDATION FOR COUNCIL ACTION

Subject: Approve a resolution to authorize the land acquisition for the Upper Waller Sanitary Sewer Overflow Project, a portion of the Austin Clean Water Program, to acquire a temporary staging and materials storage site easement across portions of the lots located at 3313 King Street, 627 and 631 West 34th Street, and 612, 614, 616 and 618 West 33rd Street, Austin, Travis County, Texas from Brigid Batcher Cockrum, Individually and as trustee of the James Bryant Cockrum Family Trust, as created in the last will and testament of James Bryant Cockrum, deceased, in an amount not exceed \$65,099

Amount and Source of Funding: Funding is included in the Fiscal Year 2005-2006 Capital Budget of the Austin Water Utility.



The design plans for the Upper Waller Sanitary Sewer Overflow Project, a portion of the Austin Clean Water Program, require acquisition of a temporary staging and materials storage site easement on the property located at 3313 King Street, 627 and 631 West 34th Street and 612, 614, 616 and 618 West 33rd Street, Austin, Travis County, Texas.

An independent third-party appraisal has established the fair-market value of the proposed easement at \$65,099. The owner has agreed to accept the City of Austin's offer of \$65,099 for the temporary staging and materials storage site easement across North 50 feet of Lots 1 and 2, and the North 50 feet of the West 13.33 feet of Lot 3, Block 8; the North 42 feet of the East 30 feet of Lot 3 and the North 42 feet of the West 21 feet of Lot 4, Block 8, together with 75 square feet of land vacated by ordinance recorded in Volume 6195, Page 280, Deed Records of Travis County, Texas; the North 53.35 feet of the East 21.66 feet of Lot 4 and the North 53.35 feet of Lot 5, Block 8; the South 72.6 feet of the East 21.66 feet of Lot 4 and the South 72.6 feet of Lot 5, Block 8; the South 84 feet of the East 30 feet of Lot 3 and the South 84 feet of the West 21.66 feet of Lot 4, Block 8; the South 76 feet of the East 36.66 feet of Lot 2 and the South 76 feet of the West 13.33 feet of Lot 3, Block 8; and the South 76 feet of Lot 1 and the South 76 feet of the West 6.67 feet of Lot 2, Block 8Lots 1-5, Block 8, Gypsy Grove, a subdivision in Travis County, Texas.
