(MBE/MB 30.33%), Austin, TX for construction of playground improvements and ADA accessibility for Silk Oak Playscape, in the amount of \$115,813.18 for the Base Bid, \$4,600 for Alternate #1, \$950 for Alternate #2, for a total approval amount of: \$121,363.18.

Silk Oak Park is located at 3204 Silk Oak Drive in southwest Austin. The park consists of 3.48 acres and currently contains a playscape, swings, barbecue grill and picnic tables. This contract will provide for the removal of the existing playscape, which is not in compliance with ADA, installation of an accessible Tot (2-5) play structure, Youth (5-12) Play structure, Spring Rider, Digger, Poured-In-Place Safety Surface, ADA compliant sidewalks, handrails, water fountain and new concrete footings to repair the existing picnic tables and barbecue grill. The project is estimated to be completed in Sixty (60) Working Days, weather permitting.

Bids were opened on March 30, 2006. Ceda-Tex Services, Inc. submitted the lowest of four (4) bids received. One bid was withdrawn on April 20, 2006.
