Purchasing Service Agreement RECOMMENDATION FOR COUNCIL ACTION

Subject: Authorize execution of ten 12-month supply agreements with MCKESSON MEDICAL-SURGICAL, Richmond, VA, EMERGENCY MEDICAL SUPPLY, Shepherdsville, KY, SOUTHERN SAFETY SALES, Austin, TX, TRI-ANIM HEALTH SERVICES, Sylmar, CA, SUN BELT MEDICAL/EMERGI-SOURCE, Hilton Head Island, SC, BOUND TREE MEDICAL, Dublin, OH. ALLIANCE MEDICAL, Russellville, MO, MASIMO AMERICAS, Irvine, CA, CVC INC., Arlington, TX, and TW MEDICAL, Lago Vista, TX, for medical supplies and medications in amounts not to exceed \$504,472, \$224,837.80, \$216,190, \$194,476.45, \$172,452.50, \$154,775.50, \$123,472.15, \$119,262.50, \$118,550 and \$78,760 respectively, with two 12-month extension 12 262 310 311 options in amounts not to exceed \$504,472, \$224,837.80, \$216,190, \$194,476.45, \$172,452.50, \$154,775.50, \$123,472.15, \$119,262.50, \$118,550 and \$78,760 respectively per extension option, for total agreement amounts not to exceed \$1,513,416, \$674,513.40, \$648,570, \$583,429,35, \$517,357,50, \$464,326.50, \$370,416.45, \$357,787.50, \$355,650 and \$236,280 respectively. In addition, nine items were identical bids among two or more bidders. Per Chapter 271.901 of the Local Government Code, the municipality must select from the identical bids by the casting of lots. The total award amounts listed will be adjusted based on the results of the casting of lots. Item numbers additionally awarded by the drawing of lots will be included in the contract award.

Amount and Source of Funding: Funding in the amount of \$613,999.60 is available in the Fiscal Year 2005-2006 Approved Operating Budget of the Emergency Medical Services Department. Funding In the amount of \$21,750 is available in the Fiscal Year 2005-2006 Approved Operating Budget of the Austin Fire Department. Funding for the remaining eight months of the original contract period and the extension options is contingent upon available funding in future budgets.

Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.

These contracts will provide for medical supplies, soft goods and medications used in pre-hospital patient care by the Austin-Travis County Emergency Medical Services (A/TCEMS) System.

The A/TCEMS System includes:

•The Austin-Travis County Emergency Medical Services Department, which provides Advanced Life Support response and transport to all areas inside the Travis County boundaries and outside Travis County through the Star Flight air medical program.

•The Austin Fire Department, which provides Basic Life Support first response to areas inside the City of Austin boundaries.

•The Travis County First Responder organizations, which provide both Basic Life Support and Advanced Life Support first response to areas outside the City of Austin boundaries.

The products included in the medical supply contracts are used daily to treat and stabilize the sick, traumatically injured and other types of patients which our ATCEMS System responds to 24 hours per day, 365 days per year.

Examples of products:

- Medications are used by the Paramedics to treat and stabilize patients that have had or are having a heart attack, heart complications, a stroke, breathing difficulties, a diabetic event or other ailment.
- Soft goods include all of the necessary items to administer the medications, such as breathing and alrway management items, spinal immobilization Items and bandaging and splint Items for lacerations, wounds from violent attacks and bone fractures.
- * Clast Medical Supplies would include non-capital diagnostic tools and other necessary items used by all responding agencies. Examples would include blood pressure cuffs, thermometers, laryngoscope blades and handles, glucometers, blankets and sharp containers for used I.V. ertert in de statten de bestellt in de st catheters and needle disposal.
