No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for installation of a new synchronous circuit breaker at the Oak Hill Substation. Synchronous circuit breakers are used mainly in capacitor bank installations. The breaker closes each phase separately to prevent transient voltages from entering the power system. These transients can cause interruptions and fluctuations for customers. The circuit breaker can be operated locally or by remote control to disconnect equipment from the power system for maintenance purposes. It can also be automatically operated by power system protection schemes when an overload or short circuit condition is detected, thus protecting equipment from excessive current.
