**ORDINANCE NO. 20060608-**

**AN ORDINANCE ESTABLISHING BOND PROPOSITION LANGUAGE FOR  
THE NOVEMBER 2006 SPECIAL BOND ELECTION.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The Council establishes the following bond proposition language to be presented to the voters at a special bond election on November 7, 2006, to read as follows:

**PROPOSITION NO. 1**

SHALL THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, BE  
AUTHORIZED TO ISSUE AND SELL GENERAL OBLIGATION BONDS AND  
NOTES OF THE CITY IN THE AGGREGATE PRINCIPAL AMOUNT OF  
\$103,100,000 FOR THE PUBLIC PURPOSES OF RECONSTRUCTING ROADS AND  
STREETS; CONSTRUCTING, RECONSTRUCTING, AND IMPROVING  
DRAINAGE FACILITIES RELATED TO THE ROADS AND STREETS;  
CONSTRUCTING, RECONSTRUCTING, AND IMPROVING BICYCLE AND  
PEDESTRIAN MOBILITY INFRASTRUCTURE; IMPROVING TRAFFIC SIGNAL  
SYNCHRONIZATION AND CONTROLS SYSTEMS; ACQUIRING AND  
INSTALLING TRAFFIC SIGNALS; AND ACQUIRING LAND AND INTERESTS IN  
LAND AND PROPERTY NECESSARY TO DO SO; WITH THE BONDS AND  
NOTES TO BE ISSUED IN ONE OR MORE SERIES OR ISSUES, TO MATURE  
SERIALLY OR OTHERWISE AND BEAR INTEREST AT A RATE OR RATES NOT  
TO EXCEED THE RESPECTIVE LIMITS PRESCRIBED BY LAW AT THE TIME OF  
ISSUANCE, AND TO BE SOLD AT THE PRICE OR PRICES AS THE CITY  
COUNCIL DETERMINES AND SHALL THERE BE LEVIED AND PLEDGED,  
ASSESSED, AND COLLECTED ANNUALLY AD VALOREM TAXES ON ALL  
TAXABLE PROPERTY IN THE CITY IN AN AMOUNT SUFFICIENT TO PAY THE  
ANNUAL INTEREST ON THE BONDS AND NOTES AND TO PROVIDE A  
SINKING FUND TO PAY THE BONDS AND NOTES AT MATURITY?

**PROPOSITION NO. 2**

SHALL THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, BE  
AUTHORIZED TO ISSUE AND SELL GENERAL OBLIGATION BONDS AND  
NOTES OF THE CITY IN THE AGGREGATE PRINCIPAL AMOUNT OF  
\$125,000,000 FOR THE PUBLIC PURPOSES OF DESIGNING, CONSTRUCTING,

1 AND INSTALLING IMPROVEMENTS AND FACILITIES FOR FLOOD CONTROL,  
2 EROSION CONTROL, WATER QUALITY, AND STORMWATER DRAINAGE,  
3 AND ACQUIRING LAND AND INTERESTS IN LAND AND PROPERTY  
4 NECESSARY TO DO SO, INCLUDING, WITHOUT LIMITATION, ACQUISITION  
5 OF LAND INCLUDING FEE TITLE AND EASEMENTS IN THE BARTON SPRINGS  
6 CONTRIBUTING AND RECHARGE ZONES TO PROVIDE FOR THE  
7 CONSERVATION OF THE REGION'S WATER QUALITY; WITH THE BONDS  
8 AND NOTES TO BE ISSUED IN ONE OR MORE SERIES OR ISSUES, TO  
9 MATURE SERIALLY OR OTHERWISE AND BEAR INTEREST AT A RATE OR  
10 RATES NOT TO EXCEED THE RESPECTIVE LIMITS PRESCRIBED BY LAW AT  
11 THE TIME OF ISSUANCE, AND TO BE SOLD AT THE PRICE OR PRICES AS THE  
12 CITY COUNCIL DETERMINES AND SHALL THERE BE LEVIED AND PLEDGED,  
13 ASSESSED, AND COLLECTED ANNUALLY AD VALOREM TAXES ON ALL  
14 TAXABLE PROPERTY IN THE CITY IN AN AMOUNT SUFFICIENT TO PAY THE  
15 ANNUAL INTEREST ON THE BONDS AND NOTES AND TO PROVIDE A  
16 SINKING FUND TO PAY THE BONDS AND NOTES AT MATURITY?

27 COURTS, AND SWIMMING POOLS; AND ACQUIRING LAND AND INTERESTS  
28 IN LAND AND PROPERTY NECESSARY TO DO SO; WITH THE BONDS AND  
29 NOTES TO BE ISSUED IN ONE OR MORE SERIES OR ISSUES, TO MATURE  
30 SERIALLY OR OTHERWISE AND BEAR INTEREST AT A RATE OR RATES NOT  
31 TO EXCEED THE RESPECTIVE LIMITS PRESCRIBED BY LAW AT THE TIME OF  
32 ISSUANCE, AND TO BE SOLD AT THE PRICE OR PRICES AS THE CITY  
33 COUNCIL DETERMINES AND SHALL THERE BE LEVIED AND PLEDGED,  
34 ASSESSED, AND COLLECTED ANNUALLY AD VALOREM TAXES ON ALL

12 PROPOSITION NO. 7

14 SHALL THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS BE  
15 AUTHORIZED TO ISSUE AND SELL GENERAL OBLIGATION BONDS OF THE  
16 CITY IN THE AGGREGATE PRINCIPAL AMOUNT OF \$58,100,000 FOR THE  
17 PUBLIC PURPOSES OF CONSTRUCTING, RENOVATING, IMPROVING, AND  
18 EQUIPPING PUBLIC SAFETY FACILITIES, INCLUDING, WITHOUT  
19 LIMITATION, A PUBLIC SAFETY TRAINING FACILITY, POLICE STATIONS,  
20 EMERGENCY MEDICAL SERVICE BUILDINGS AND FACILITIES, A  
21 MUNICIPAL COURTHOUSE, AN ANIMAL SHELTER, AND OTHER RELATED  
22 FACILITIES AND ACQUIRING LAND AND INTERESTS IN LAND AND  
23 PROPERTY NECESSARY TO DO SO; WITH THE BONDS AND NOTES TO BE  
24 ISSUED IN ONE OR MORE SERIES OR ISSUES, TO MATURE SERIALY OR  
25 OTHERWISE AND BEAR INTEREST AT A RATE OR RATES NOT TO EXCEED  
26 THE RESPECTIVE LIMITS PRESCRIBED BY LAW AT THE TIME OF ISSUANCE,  
27 AND TO BE SOLD AT THE PRICE OR PRICES AS THE CITY COUNCIL  
28 DETERMINES AND SHALL THERE BE LEVIED AND PLEDGED, ASSESSED,  
29 AND COLLECTED ANNUALLY AD VALOREM TAXES ON ALL TAXABLE  
30 PROPERTY IN THE CITY IN AN AMOUNT SUFFICIENT TO PAY THE ANNUAL  
31 INTEREST ON THE BONDS AND NOTES AND TO PROVIDE A SINKING FUND

41 FACILITIES RELATED TO THE ROADS AND STREETS; IMPROVING AND

1 RECONSTRUCTING BICYCLE AND PEDESTRIAN MOBILITY  
2 INFRASTRUCTURE; IMPROVING TRAFFIC SIGNAL SYNCHRONIZATION AND  
3 CONTROLS SYSTEMS; ACQUIRING AND INSTALLING TRAFFIC SIGNALS;  
4 AND ACQUIRING LAND AND INTERESTS IN LAND AND PROPERTY

THE ISSUANCE OF \$90,000,000 IN TAX SUPPORTED GENERAL OBLIGATION BONDS AND NOTES FOR CONSTRUCTING AND EQUIPPING A NEW CENTRAL LIBRARY FACILITY AND ACQUIRING LAND AND INTERESTS IN LAND AND PROPERTY NECESSARY TO DO SO; AND THE LEVY OF A TAX SUFFICIENT TO PAY FOR THE BONDS AND NOTES.

PROPOSITION NO. 6

THE ISSUANCE OF \$25,000,000 IN TAX SUPPORTED GENERAL OBLIGATION BONDS AND NOTES FOR CONSTRUCTING, RENOVATING, IMPROVING, AND EQUIPPING CULTURAL FACILITIES AND ACQUIRING LAND AND INTERESTS IN LAND AND PROPERTY NECESSARY TO DO SO; AND THE LEVY OF A TAX SUFFICIENT TO PAY FOR THE BONDS AND NOTES.

PROPOSITION NO. 7

THE ISSUANCE OF \$58,100,000 IN TAX SUPPORTED GENERAL OBLIGATION BONDS AND NOTES FOR CONSTRUCTING, RENOVATING, IMPROVING, AND EQUIPPING PUBLIC SAFETY FACILITIES, INCLUDING, WITHOUT LIMITATION, A PUBLIC SAFETY TRAINING FACILITY, POLICE STATIONS, EMERGENCY MEDICAL SERVICE BUILDINGS AND FACILITIES, A MUNICIPAL COURTHOUSE, AN ANIMAL SHELTER, AND OTHER RELATED FACILITIES AND ACQUIRING LAND AND INTERESTS IN LAND AND PROPERTY NECESSARY TO DO SO; AND THE LEVY OF A TAX SUFFICIENT TO PAY FOR THE BONDS AND NOTES.
