Purchasing Service Agreement RECOMMENDATION FOR COUNCIL ACTION

Subject: Authorize award and execution of a 12-month requirements supply contract with ACT PIPE & SUPPLY, INC., Pflugerville, TX, for the purchase of valves of various types and sizes for the Austin Water Utility in an estimated amount not to exceed \$58,843.75, with two 12-month extension options in an estimated amount not to exceed \$58,843.75 per extension option, for a total estimated contract amount not to exceed \$176,531.25.

Amount and Source of Funding: Funding in the amount of \$19,615 is available in Fiscal Year 2005-2006 Approved Operating Budget of the Austin Water Utility. Funding for the remaining eight months of the original contract period and extension options is contingent upon available funding in future budgets.

Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.

This contract is necessary to ensure an adequate supply of valves for replacing existing broken valves, installation of new subdivisions, and where new hydrants are required.
