

Austin Water Utility RECOMMENDATION FOR COUNCIL ACTION

Subject: Approve negotiation and execution of an Interlocal Agreement with Travis County for the reimbursement to the City for engineering and construction services necessary for fire hydrant adjustments and relocations along the Moya Hike and Bike Trail adjacent to Burleson Road.

Amount and Source of Funding: The County will pay all costs for the Austin Water Utility, including the cost of surveying, design, construction, Inspection, and testing. The total amount to be paid to the City by the County for the City project is the actual cost of the work, presently estimated to be \$40,000, but not-to-exceed \$50,000 without further authorization by the Travis County Commissioners Court.



Travis County and City staff have identified six fire hydrants, along the Moya Hike and Bike trail adjacent to Burleson Road, that require relocation. The existing hydrants are "in" the trail and have been identified as obstructions. The existing hydrants will be relocated adjacent and away from the trail at a minimum of 18 inches from the trail in order to provide the clearance required by the American Disabilities Act. The fire hydrants will move only a few feet and will continue to serve the surrounding area.

City staff will provide the design and construction services.
