Funds will be used for consultant services, groundwater monitoring, and the design, construction, and operation of an active gas extraction system. This agenda includes related items for the professional services and construction contracts. Funding in the amount of \$449,000 is available in the Fiscal Year 2005-2006 Approved Ending Balance of the Mueller Airport Disposition Fund.
