Public Works RECOMMENDATION FOR COUNCIL ACTION

Subject: Authorize execution of a construction contract with LEWIS CONTRACTORS INC., Georgetown, TX, for the Austin Clean Water Program: Downtown/White Horse Trail Phase II Wastewater Improvements Project in an amount not to exceed \$1,519,133 plus an amount not to exceed \$75,957 contingency, for a total contract amount not to exceed \$1,595,090.

Amount and Source of Funding: Funding in the amount of \$1,595,090 is available in the Fiscal Year 2005-2006 Capital Budget of the Austin Water Utility.

This construction contract will provide for the installation of 2,426 feet of new wastewater pipeline beginning at the north right-of-way line of White Rock Drive between Bull Creek Road and Woodview Drive proceeding north along an unnamed tributary past White Horse Trail to a point south of Twin Oaks Drive. The portion of work adjacent to the creek will include stream bank stabilization. The improvements are intended to replace aging and deteriorated facilities and eliminate wastewater overflows that have occurred in these areas. The project is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows.

The proposed wastewater line improvements include the installation of 2,426 feet of eight-inch wastewater line, 18 new manholes, and approximately 900 feet of stream bank stabilization.

Due to the potential for conflicts when installing underground utilities and for unknown subsurface conditions while working in the unnamed tributary, a 5% contingency has been included to allow for the expeditious processing of any future change orders. The contract allows 200 work days for substantial completion and another 45 work days for final completion of this project.


Bid documents were distributed to four general contractors. Bids were opened April 20, 2006. The low bidder, Lewis Contractors, Inc. submitted the lowest and single bid:

The contractor's choice of work methodology provides for subcontracting opportunities in 11 areas which are listed below. Participation subgoals stated in the solicitation were 5.13% African American (MB); 9.32% Hispanic (MH); 0% Native American (MN); 0.68% Asian Americans (MA); 5.37% WBE.
