**Purchasing Service Agreement  
RECOMMENDATION FOR COUNCIL ACTION**

**Subject:** Authorize award, negotiation and execution of Amendment No. 2 to the contract with **AFFILIATED COMPUTER SERVICES INC.**, Lexington, KY, to extend the contract for a 12-month period for the continuation of software support, upgrades, and maintenance services for the Banner Human Resources Management System Software in an amount not to exceed \$97,608, with four 12-month extension options in an amount not to exceed \$102,488 for the first extension option, \$107,613 for the second extension option, \$112,994 for the third extension option, \$118,643 for the fourth extension option, for a revised total contract amount not to exceed \$2,532,083.

**Amount and Source of Funding:** Funding in the amount of \$97,608 is available in Fiscal Year 2005-2006 Approved Operating Budget of the Financial and Administrative Services Department. Funding for the extension options is contingent upon available funding in future budgets.

**Fiscal Note:** A fiscal note is not required.

This amendment is for the continuation of software support and maintenance services for Banner and its related software modules. The continuing operation of the City's Banner system is dependent upon this amendment for updates and ongoing technical support from the contractor. The software is proprietary to Affiliated Computer Services, Inc. and unavailable from another source.

The Banner system is the City's human resource management and payroll system. The system was acquired on March 9, 1995 following council approval of a contract with Systems and Computer Technology Corporation (SCT). SCT was subsequently acquired in June 2001 by the current contractor Affiliated Computer Services. The Technical Currency program is the software maintenance and support service.
