**Purchasing Service Agreement
RECOMMENDATION FOR COUNCIL ACTION**

Subject: Authorize execution of Amendment No. 4 to Contract No. S060194 with ALLIED BARTON SECURITY SERVICES LLC, Austin, TX, to continue security guard services at the Cameron Road Campus for the Building Services Division of the Finance and Administrative Services Department in an estimated amount not to exceed \$10,538.40, for an estimated total not to exceed contract amount of \$143,351.09.

Amount and Source of Funding: Funding is available in the Fiscal Year 2005-2006 Approved Operating Budget of the Cameron Road Campus Fund.

Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.

Prior Council Action: Council authorized Amendment No. 1 to the Allied Barton contract on March 9, 2006.

On October 6, 2005, Council approved the purchase of commercial property at 8301 Cameron Road for occupancy by various City departments. On January 3, 2006 the City of Austin purchased the property.

An administrative award in an amount not to exceed \$47,000 was made to continue with Allied Barton, the existing security service company, to avoid gaps in property protection. Amendment No. 1 extended the contract to allow for continued coverage while bids were being solicited and evaluated. Additional administrative approval has extended the contract through June 30, 2006.

The bids have been evaluated and an RCA is being brought forward for Council authorization on this date. This amendment will allow time to complete pre-contractual requirements and aid in a smooth transition between security companies. This amendment will extend the contract through July 14, 2006.

The Cameron Road campus represents an approximate \$22,125,000 investment for the City of Austin, including 33 acres of land and 276,141 square feet of building space.
