No Subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the turnkey purchase of material and Installation of two swimming pool heaters for the Dick Nichols swimming pool. This pool will be utilized by the Austin Independent School District (AISD) for swim team practice. The Aquatics division will conduct swim lessons for the public and train staff on a year round basis. This pool currently has no heater system and is normally closed during the winter months. With the new heater system, the citizens of Austin will be able to utilize this facility for recreational swimming during the entire year. When AISD utilizes the facility for the heaters at the pools a fee will be charged according to the Approved Fee Schedule.
