The City of Taylor is considering expanding their ETJ to include property located within an area that was once the subject of a dispute between the City of Austin and the City of Taylor.

In 1985 the two cities negotiated an agreement regarding their respective ETJs and Austin agreed to not annex any additional land that would extend its ETJ into the "Negotiated ETJ with Taylor" and Taylor agreed not to take any action that would extend its ETJ beyond the "Negotiated ETJ with Taylor." Due to a 1987 disannexation of the strip annexations that originally extended the Austin ETJ, this agreement no longer has any effect on the City of Austin.

The Taylor City Council approved a resolution at their May 23, 2006 meeting requesting that the Austin City Council rescind the 1985 agreement allowing Taylor to extend its ETJ to include certain property that is currently approximately nine miles from the Austin city limit.

Staff recommends this termination of the 1985 agreement, which will allow Taylor to expand its ETJ into the negotiated ETJ area.

WHEREAS, these negotiations resulted in a draft agreement, which the City Council approved by Resolution on June 20, 1985; and,

WHEREAS, further negotiations have resulted in a revised agreement, which is attached hereto and made a part hereof as Exhibit "A"; and,

WHEREAS, the City Council finds that the "Agreement Between the City of Austin and the City of Taylor Regarding their Respective Extraterritorial Jurisdictions", Exhibit "A" hereto, is acceptable and that the approval of this agreement is in the best interest of the two cities and the persons residing in any disputed territory and is not injurious to the interests of the City of Austin: NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the City Council hereby authorizes the City Manager to enter into the "Agreement Between the City of Austin and the City of Taylor Regarding their Respective Extraterritorial Jurisdictions", said agreement being attached hereto and made a part hereof as Exhibit "A"; provided, however, that the consent hereby granted shall become effective only upon the adoption of an ordinance or resolution by the governing body of the City of Taylor, either before or after the date hereof, granting its consent to said agreement.







A RESOLUTION REQUESTING THAT THE CITY OF AUSTIN RESCIND AND REPEAL AN AGREEMENT BETWEEN THE CITY OF AUSTIN AND THE CITY OF TAYLOR RELATING TO ACTIVITY IN THEIR RESPECTIVE EXTRATERRITORITAL JURISDICTIONS, AND AUTHORIZING THOSE MATTERS PROPER AND NECESSARY THERETO.

BE IT RESOLVED BY THE CITY OF TAYLOR:

WHEREAS, the City Council of the City of Taylor, Texas, approved by Resolution an agreement with the City of Austin on June 25, 1985 relating to activities in their respective extraterritorial jurisdictions; and

WHEREAS, the City Council of the City of Taylor, Texas, finds that this agreement no longer serves a valid and useful purpose; and

WHEREAS, the City of Taylor, Texas, further requests that the City of Austin rescind and repeal all portions of the June 25, 1985 resolution and agreement.
