This action authorizes the City to apply for \$60,730 in grant renewal funding from the U.S. Department of Justice, Office of Justice Programs, National Institute of Justice. The grant period runs from October 1, 2006 to September 30, 2007. No match is required. The total project cost is \$60,730.

This funding will be used to provide the APD Crime Lab with a Serology Screener at \$60,730. The screener will coordinate with investigators and lab personnel to locate evidence and ensure the integrity of the chain of custody during the screening stain collection and storage of backlogged Sexual Assault Kits. The goal of the project is to process 400 backlogged kits.

This grant addresses the Police Department goal of improving efficiency and effectiveness in order to provide information for daily operations, analysis and strategic planning, and to increase the likelihood of the successful prosecution of criminals. It also addresses the Forensic Science Service activity of providing the timely and accurate forensic science and operational support to APD, local law enforcement and judicial agencies so they can successfully resolve investigations.
