

The property and residence located at 7138 Dixie Drive are part of the Stream Restoration Program. The purpose of the program is to provide protection for structures and public amenities by controlling streambank erosion and preserving the natural character of our creeks.

The lot to be acquired is approximately 8,600 square feet with improvements that include a two-story wood frame 1,194 square feet single-family dwelling. The market value of the property including improvements is \$107,000, as determined by independent appraisal. The owner has agreed to accept the City's offer.
